

SURVEYORS DESCRIPTION

The following described tract of land is part of the west half of the Northwest Quarter of Section 8, T-6-S-R-6-E, Pusheta Township, Auglaize County, Ohio, and is more particularly described as follows.

Commencing at a railroad spike at the Southwest corner of the Northwest Quarter of Section 8 Pusheta Township (Railroad spike being at the intersecting centerlines of C.R. # 133-A, formerly the Hardin Pike, and T.S.R. # 126, formerly the Owl Creek Road) Thence East along the center of T.S.R. #126, 971.90 feet to an iron pin, this being the PLACE OF BEGINNING.

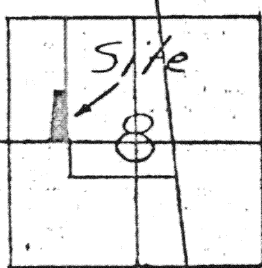
Thence continuing East along the center of T.S.R. #126, 352.56 feet to an iron pin on the east line of the west half of the Northwest Quarter of Section 8, Pusheta Township.

Thence N 00° 14' E, along the east line of the west half of Roy Foos steel fence post set at 16.10 feet) 701.64 feet to a steel fence post.

Thence S 88° 44' W, 215.57 feet to an iron pine.

Thence S 11° 21' W (passing through a 8" wood fence post set at 695.22 feet) 710.77 feet to the iron pin in the center of T.S.R. #126 which was the PLACE OF BEGINNING.

The above described tract of land contains 4.55 acres more or less subject to 0.16 acres more or less dedicated to the public for highway purposes and to all legal easements of record.
