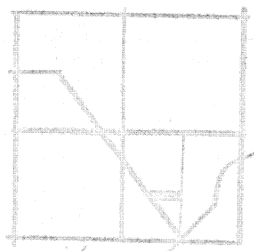

### SURVEYORS DESCRIPTION

The following described tract of land is part of the Southwest Quarter of the Southeast Quarter of Section 25, Town 6, South, Range 4 East, St. Marys Township Auglaize County, Ohio, and is more particularly described as follows.  
Commencing at the stone at the Southwest corner of the Southeast Quarter of Section 25, St. Marys Township, (Stone being in the center of Township Road #90, formerly the Southland Road.)

Thence South  $88^{\circ} 45' E$ , along the center of Township Road #90, formerly Southland Road, 1150.00 feet to a capped nail in the center of County Road #65-A, formerly the New Bremen-New Knoxville Road.

Thence N  $41^{\circ} 15' E$ , along the center of County Road #65-A, formerly the New Bremen-New Knoxville Road, 154.65 feet to a capped nail in the center of Township Road #96-A, formerly Henschen Road.

Thence N  $36^{\circ} 12' W$ , along the center of Township Road #96-A, formerly Henschen Road, 929.80 feet to an iron pin, this being the PLACE OF BEGINNING.

Thence continuing N  $36^{\circ} 12' W$  along the center of Township Road #96-A, formerly Henschen Road, 300.00 feet to a railroad spike.

Thence N  $85^{\circ} 41' E$  (passing through an iron pipe set at 35.00 feet) 837.41 feet to an iron pipe set on the east line of the Southwest Quarter of the Southeast Quarter of Section 25, St. Marys Township.

Thence S  $1^{\circ} 30' W$  along the East line of the Southwest Quarter of the Southeast Quarter of Section 25, St. Marys Township, 241.11 feet to an iron pipe.

Thence S  $84^{\circ} 23' W$  (passing through an iron pipe set at 640.32 feet) 655.25 feet to the iron pin in the center of Township Road #96-A, formerly Henschen Road, which was the PLACE OF BEGINNING.

The above described tract of land contains 4.25 acres of land more or less subject to 0.206 acres more or less dedicated to the public for highway purposes and to all legal easements of record.
