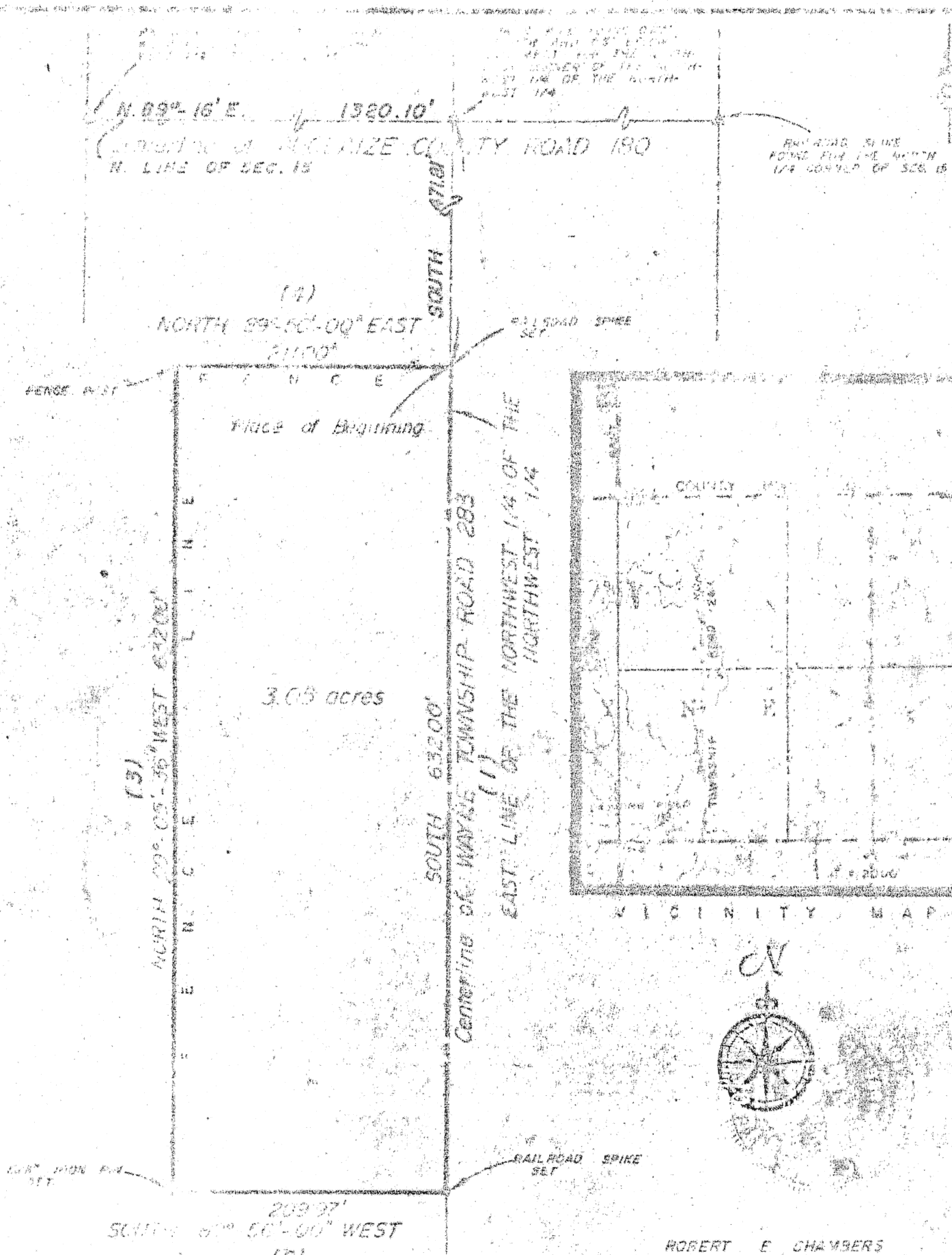

DESCRIPTION
Job #8821

Being a parcel of land in Wayne Township, Auglaize County, State of Ohio in the Northwest $\frac{1}{4}$ of Section 15, Township 5 South, Range 8 East and being more particularly described as follows:

Commencing for reference at a P.K. nail found at the northwest corner of the northwest $\frac{1}{4}$ of Section 15, this point being on the centerline of Auglaize County Road 180 and the north line of Section 15, thence north $89^{\circ}-16'$ east on and along said centerline and north line for a distance of 1320.10 feet to a point on the centerline of Wayne Township Road 283 and east line of the northwest $\frac{1}{4}$ of the northwest $\frac{1}{4}$ of Section 15, said point being 0.67 feet south of an iron pipe found; thence south along said centerline and east line for a distance of 471.81 feet to a railroad spike set for the place of beginning for the parcel to be conveyed by this instrument -

(1) Thence continuing along the centerline of Wayne Township Road 283 and east line of the northwest $\frac{1}{4}$ of the northwest $\frac{1}{4}$, south for a distance of 632.00 feet to a railroad spike set -

(2) Thence south $89^{\circ}-50'-00''$ west for a distance of 209.97 feet to a $\frac{5}{8}$ " iron pin set -

(3) Thence north $00^{\circ}-05'-36''$ west for a distance of 632.00 feet to a fence post -

(4) Thence north $89^{\circ}-50'-00''$ east for a distance of 211.00 feet to the place of beginning.

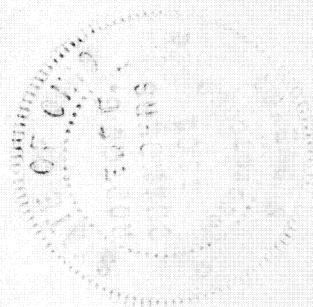
Containing in all 3.05 acres of land more or less.
