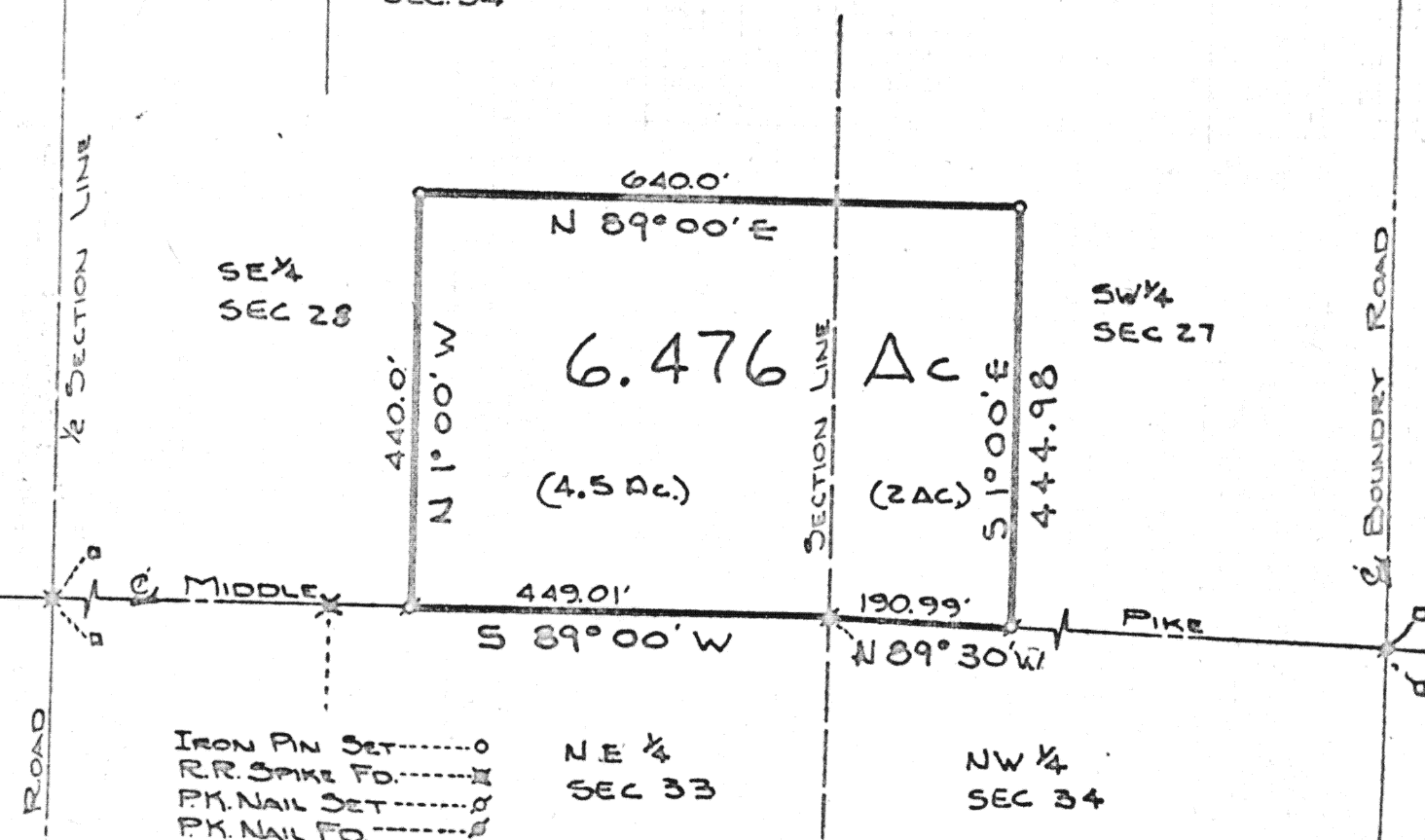

# UPPENKAMP SURVEY

Scale: 1"=200'



Being 6.476 Acres located in the South-East corner of Section 28 (4.5 Ac and the South-West corner of Section 27 (2 Ac.), T-5-S, R-7-E, Union Township, Auglaize County, Ohio and being further described as follows: Commencing at a PK nail over a stone at the South-East corner of Section 28, also being the South-West corner of Section 27 and the center of C.R.# 150 (Middle Pike), said point being the PLACE OF BEGINNING for the tract of land herein described.

Thence South 89° 00' West with the center of C.R.# 150 and the South line of Section 28, a distance of 449.01 feet to a PK nail set.

Thence North 01° 00' West, a distance of 440.00 feet to an iron bar set.

Thence North 89° 00' East, a distance of 640.00 feet to an iron bar set.

Thence South 01° 00' East, a distance of 444.98 feet to a PK nail set in the South line of Section 27 and the center of C.R.# 150.

Thence North 89° 30' West, a distance of 190.99 feet to a PK nail and PLACE OF BEGINNING.

Containing in all 6.476 Acres and being subject to all legal easements and R/W of record.
