



SURVEY DESCRIPTION  
LOT 5

Scale:

Being a parcel of land situated in the Village of Waynesfield, Auglaize County, Ohio and being part of Outlot 1 as recorded in 1974, in Plat Book 225, Page 699 in the office of the Auglaize County Recorder -

Commencing for reference at the northwest corner of Lot 58, this point being the intersection of the south line of a sixteen and fifty hundredths (16.50) foot public alley with the east line of Cherry Street -

Thence north, on the east line of Cherry Street Extended, a distance of sixteen and fifty hundredths (16.50) feet to the south line of Outlot 1 as marked by a 5/8 inch iron rod; thence north 89°-32'-00" east, along the south line of Outlot 1, a distance of one hundred fifty and zero hundredths (150.00) feet to a 5/8 inch iron rod; thence north eighty-three and fifty hundredths (83.50) feet to a 5/8 inch iron rod. This point being the place of beginning for the parcel to be conveyed by this instrument -

(1) Thence north a distance of eighty-three and fifty hundredths (83.50) feet to a 5/8 inch iron rod set on the north line of Outlot 1 -

(2) Thence north 89°-32'-00" east, along the north line of Outlot 1, a distance of one hundred thirteen and zero hundredths (113.00) feet to a 5/8 inch iron rod -

(3) Thence south a distance of eighty-three and fifty hundredths (83.50) feet to a 5/8 inch iron rod -

(4) Thence south 89°-32'-00" west a distance of one hundred thirteen and zero hundredths (113.00) feet to the place of beginning.

Containing 0.22 acres of land more or less.

Subject to all easements and right-of-way of record.

Note: Bearings refer to the east line of Cherry Street as being north.
