DESCRIPTION OF 2.544 ACRES

Being 2.544 Acres located in the south-east quarter of Section 1, T-6-S, R-4-E, St. Marys Township, Auglaize County, Ohio and being further described as follows.

Commencing the the center line intersection of Washington Pike and Barrington Road as described in Deed Book 230, Page 802.

Thence N 19° 45' 30" W with the center line of Barrington Road, a distance of 324.04 feet.

Thence with a curve to the right with a radius of 391.72 feet, a length of 119.88 feet and a chord of 118.62 feet to a point.

Thence N 02° 10' 30" W, a distance of 38.00 feet to a railroad spike and PLACE OF BEGINNING, for the tract of land herein described.

Thence N 83° 45' 30" E with the center of a creek, a distance of 350.38 feet to a point.

Thence N 04° 09° E, a distance of 374.07 feet to anciron pipe set in the north line of lands described in Deed Book 230 Page 802, passing through an iron pipe at 30.0 feet.

Thence N 90° 00' W along said property line, a distance of 212.81 feet to a railroad spike in the center of Barrington Road.

Thence S 10° 35' 30" W, a distance of 50.00 feet to a rail road spike Thence with a curve to the right with a radius of 310.51 feet, a length of 185.24 feet and a chord of S 27° 45" 30" W, a distance of 183.29 feet to a railroad spike.

Thence with a curve to the left with a radius of 211.56 feet, a leggth of 171.82 feet and a chord of S 24° 22' W, a distance of 169.06 feet to a railroad spike.

Thence S 02° 10° 30" E, a distance of 45.00 feet to a railroad spike and 45.87 get pelecen 9/1/77
