

## SURVEY DESCRIPTION (3.792 ACRE TRACT)

Commencing for reference at a railroad spike at the southeast corner of said Section 34-

Thence, north, along the east line of said southeast quarter of Section 34, a distance of one thousand one hundred seventy-five (1175.00) feet to a 5/8 inch iron bar at the northeast corner of a tract of land conveyed to Reger Koenig by deed recorded in deed volume 205, page 989. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing, north, along the last described line, a distance of six hundred twenty-eight and 22/100 (628.22) feet to a 5/8 inch iron bar-

Thence, south 89°56'18" west, a distance of two hundred sixty-two and 96/100 (262.96) feet to a 5/8 inch iron bar-

Thence, south, a distance of six hundred twenty-eight and 22/100 (628.22) feet to a 5/8 inch iron bar in the north line of the afore mentioned Roger Koenig's land-

Thence, north 89°56'18" east, along said Roger Koenig's north line, a distance of two hundred sixty-(wo and 96/100 (262.96) feet to the place of beginning.
