


Commencing at the south-east corner of Out Lot # 32, said point being marked by an iron bar.

"G" Thence North  $00^{\circ} 15'$  East, a distance of 224.27 feet to the center line of an open creek and the PLACE OF BEGINNING for the tract of land herein described, said point being referenced by an iron pipe set North  $00^{\circ} 15'$  East, 20.00 feet.

"C" Thence North  $40^{\circ} 31' 20''$  West with the center of creek, a distance of 174.30 feet to a point referenced by an iron pipe set North  $20^{\circ} 18'$  East, 20.00 feet.

"B" Thence North  $28^{\circ} 08'$  West with the center of creek, a distance of 219.73 feet to a point referenced by an iron pipe set North  $61^{\circ} 43'$  East, 20.00 feet.

"A" Thence North  $04^{\circ} 17' 20''$  East, a distance of 117.80 feet to a point referenced by an iron pipe set North  $89^{\circ} 56'$  East, 24.6 feet

"J" Thence North  $89^{\circ} 56'$  East, a distance of 210.00 feet to an iron bar found.
