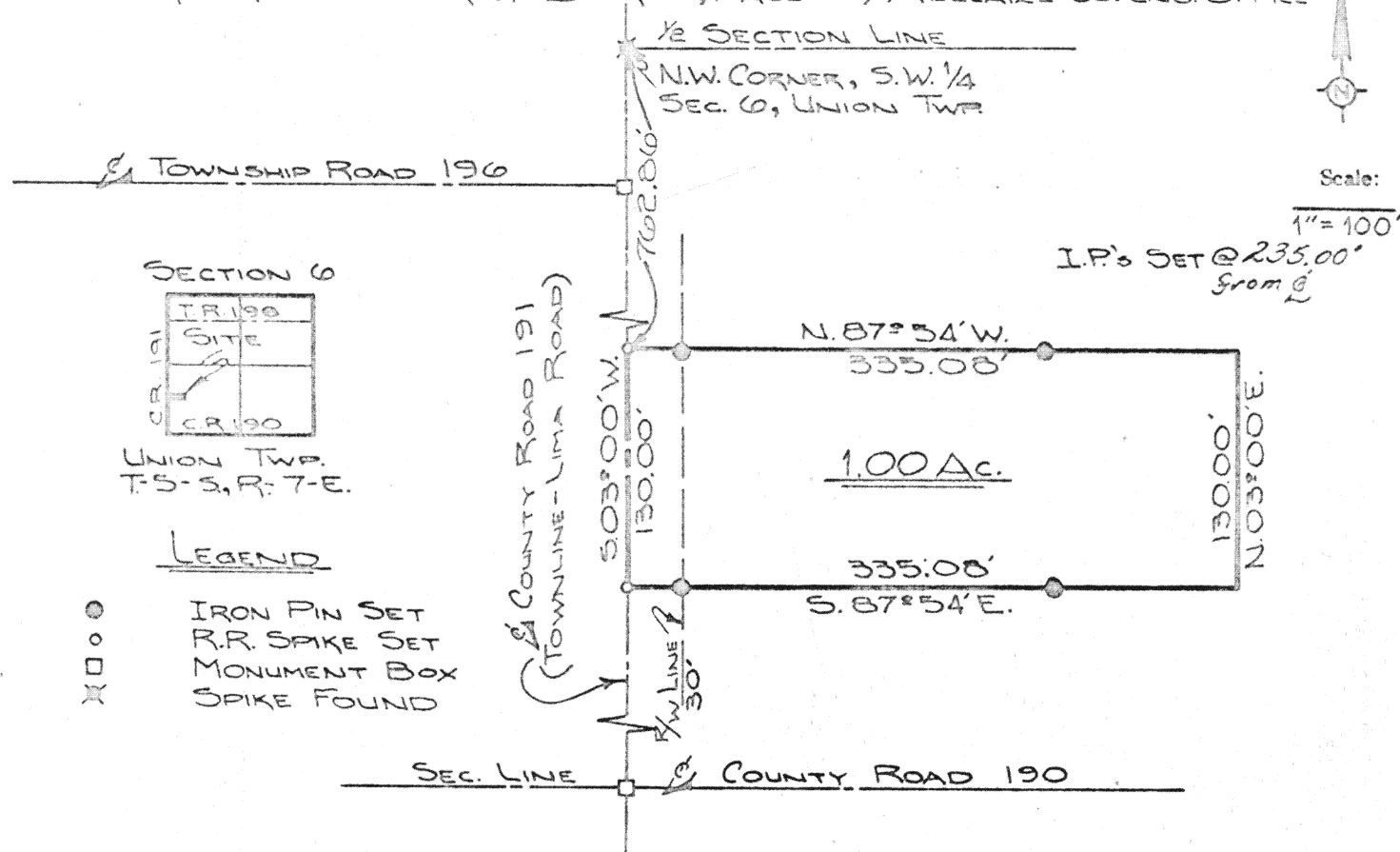


PLAT RECORDED IN SURVEY BOOK 0, PAGE 25, AUGLAIZE CO. ENG. OFFICE



The following described tract of land is part of the Northwest Quarter of the Southwest Quarter of Section 6, Union Township, Town 5 South, Range 7 East, Auglaize County Ohio, and is more particularly described as follows:

Commencing at a spike in the Northwest corner of the Southwest Quarter of Section 6, Union Township and in the centerline of County Road 191 (formerly known as the Townline - Lima Road);

Thence S. 03° 00' W. along the centerline of C. R. 191 and the west line of Section 6, Union Township, a distance of 762.86 feet to a spike which is the PLACE OF BEGINNING;

Thence continuing S. 03° 00' W. along the centerline of County Road 191 a distance of 130.00 feet to a spike;

Thence S. 87° 54' E. a distance of 335.08 feet to a point, passing thru an iron pin at 30.00 feet in the East right-of-way line of County Road 191;

Thence N. 03° 00' E. a distance of 130.00 feet to a point;

Thence N. 87° 54' W. a distance of 335.08 feet to a spike, passing thru an iron pin at 305.08 feet in the East right-of-way line of County Road 191, said spike was the PLACE OF BEGINNING.

Containing 1.000 acres of which 0.089 acres has been dedicated for highway purposes. The above described tract of land is subject to all legal easements. Previous deed reference: Volume 219, Page 488.
