



CAYWOOD SURVEY DESCRIPTION

Being a parcel of land situated in Out Lot Number 4 of McKee and Scott's Out Lots in the city of St. Marys, Auglaize County, Ohio. Being more particularly described as follows:

Scale:

Commencing for reference at the intersection of the north corporation line of the City of St. Marys with the centerline of Defiance Road-

Thence, south, along the centerline of Defiance Road, a distance of twenty (20.00) feet to the northeast corner of a 0.75 acre tract of land conveyed to the Church of Jesus Christ of Latter Day Saints by deed volume 169, page 689-

Thence, south 890 hit east along the north line of said Church parcel, a distance of two hundred twenty-one (221.00) feet to a 5/8 inch iron bar-

Thence, south, along the east line of said Church parcel, a distance of one hundred forty-six and 50/100 (146.50) feet to a wood stake at the southeast corner thereof. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing south, a distance of seventy and 53/100 (70.53) feet to a 5/8 inch iron bar-

Thence, north 89044' west, a distance of eighty-one and 57/100 (81.57) feet to the southeast corner of a tract of land conveyed to John and Reta Caywood by deed recorded in deed volume 214,

Thence, north 00°51'24" east along the east line of said Caywood tract, a distance of seventy (70.00) feet to the northeast corner thereof-

Thence, continuing north 00051'24" east, a distance of (0.53) foot to a point in the south line of the afore mentioned Church tract-

Thence, south 89044' east along the south line of said Church tract, a distance of eighty and 52/100 (80.52) feet to the place of beginning.

Containing 0.131 acre of land more or less.

Subject to all easements and right-of-way of record.
