Beginning for reference at a railroad spike set at the northwest corner of Out Lot 63 and being in the centerline of State Route 219;

Thence, with the east line of Out Lot 62, a distance of 180.00 feet to an iron pipe set at the **True Point of Beginning** of the tract herein described;

Thence, with a new division line and an angle to the right of 88°53', a distance of 117.30 feet to an iron pipe set in the west line of a part of Out Lot 63 owned be W. & W. Mueller as recorded in Official Record 105 Page 438;

Thence, with the west line of said W. & W. Mueller tract, with an angle to the left of 88°53', a distance of 140.00 feet to an iron pipe set in the north line of a 2.641 acre tract of land owned by R. Feathers as recorded in Official Record 182 Page 421;

Thence, with the north line of said 2.641 acre tract, with an angle to the left of 91°07', a distance of 117.30 feet to an iron pipe set in the west line of Out Lot 63;

Thence, with the west line of said Out Lot 63, with an angle to the left of 88°53', a distance of 140.00 feet to the **True Point of Beginning**, containing 0.377 acres more of less and being subject to all legal easements, rights of way, agreements and restrictions of record.
