


The following described tract of land is part of the Northwest Quarter of the Northeast Quarter of Section 8, Logan Township, Town 5 South, Range 5 East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a spike over the stone in the centerline of Township Road 188, (formerly known as the Hunt Road), and at the Southwest corner of the Northwest Quarter of the Northeast Quarter of Section 8, Logan Township, said spike being the PLACE OF BEGINNING;

Thence N. 00° 24' E. along the half section line of Section 8, Logan Township, a distance of 208.71 feet to an iron pin;

Thence S. 89° 30' E. a distance of 417.42 feet to an iron pin;

Thence S. 00° 24' W. a distance of 208.71 feet to a spike in the centerline of Township Road 188;

Thence N. 89° 30' W. along the centerline of Township Road 188, a distance of 417.43 feet to a spike which was the PLACE OF BEGINNING.

Containing 2.000 acres of which 0.140 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements. Previous deed reference: Volume 187, Page 876.
