Thence continuing N.01°-41'E. along the west line of section 18 Duchouquet Township, a distance of 195.79' feet to an iron pin,

Thence N.85-56'E. a distance of 480.53' feet to a point in the centerline of the Shearer Ditch,

Thence S.13°-34'-45'W. along the centerline of the Shearer Ditch passing through a chiseled "+" on the headwall at 189.85' feet for a total distance of 246.27' feet to an iron pin,

Thence N.88°-42'-07"W. a distance of 427.39' feet to the PLACE OF BEGINNING.

Thence continuing S.88°-42'-07"E., passing through an iron pin set at 774.74' feet which is the west right-of-way line of Ohio State Route 198, for a total distance of 807.20' feet to a spike in the centerline of State Route 198,

Thence N.21-07'W. along the centerline of State Route 198 a distance of

27.05' feet to a spike,

Thence N.88²-42'-07'W., passing through an iron pin set at 32.46' feet which is the west right-of-way line of State Route 198, for a total distance of 713.00' feet to an iron pin,

Thence N.65°-55'-16"W. a distance of 77.94' feet to a chiseled "+" in the concrete headwall of the Shearer Ditch, said "+" also indicating the centerline of the Shearer Ditch,

Thence S.13-34'-45"W. a distance of 56.42' feet to the PLACE OF BEGINNING.
