



The following described tract of land is part of the Southeast Quarter of Section 7, Pusheta Township, Town 6 South, Range 6, East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a spike in the intersection of County Road 133A, (formerly known as the Hardin Pike) and Township Road 126 (formerly known as the Owl Creek Road), also being the Northeast corner of the Southeast Quarter of Section 7, Pusheta Township;

Thence N. 87° 59' W. along the North line of the Southeast Quarter of Section 7, Pusheta Township and the centerline of T.R. 126, a distance of 1151.12 feet to a spike which is the PLACE OF BEGINNING;

Thence continuing N. 87° 59' W. along the North line of the Southeast Quarter of Section 7, Pusheta Township and the centerline of Township Road 126, a distance of 150.00 feet to a spike;

Thence S. 02° 23' W. a distance of 290.40 feet to an iron pin, passing thru an iron pin at 20.00 feet in the right-of-way line of Township Road 126;

Thence S. 87° 59' E. a distance of 150.00 feet to an iron pin;

Thence N. 02° 23' E. a distance of 290.40 feet to a spike, passing thru an iron pin at 270.40 feet in the South right-of-way line of Township Road 126, said spike was the PLACE OF BEGINNING.

Containing 1.000 acre of which 0.069 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements. Previous deed reference: Vol. 151, Pg. 126. This plat is recorded in survey book D, page 380, in the Auglaize County Engineer's Office.
