



The following described tract of land is part of the Southwest Quarter of the Southwest Quarter of Section 12, Union Township, Town 5 South, Range 7 East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a box in the centerline of T.R. 241 (formerly known as the Graham Road) and C.R. 180 (formerly known as the Fairmount Road), and in the Southwest corner of Section 12, Union Township;

Thence N.89°45'E. along the centerline of C.R. 180 and the South line of Section 12, Union Township, a distance of 905.70 feet to a spike, which is the PLACE OF BEGINNING;

Thence continuing N.89°45'E. along the centerline of C.R. 180 and the South line of Section 12, Union Township a distance of 250.00 feet to a spike;

Thence N.00°00'E. a distance of 379.00 feet to an iron pin, passing thru an iron pin at 25.00 feet;

Thence S.89°45'W. a distance of 250.00 feet to an iron pin;

Thence S.00°00'W. a distance of 379.00 feet to a spike, passing thru an iron pin at 354.00 feet, said spike was the PLACE OF BEGINNING.
