



LOCATION PLAN

The following described tract of land is part of the Southeast Quarter of the Southeast Quarter of Section 27, Union Township, Town 5 South, Range 7 East, Auglaize County, Ohio; and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of Section 27, Union Township, and in the intersection of C.R. 150 (formerly known as the Middle Pike) and C.R. 231 (formerly known as the Wrestle Creek Road), said box being the PLACE OF BEGINNING;

Thence N.00°00'E. along the East line of Section 27, Union Township, and the centerline of C.R. 231 a distance of 500.59 feet to a spike;

Thence N.89°23'30"W. a distance of 350.50 feet to an iron pin, passing thru an iron pin at 30.00 feet in the West right-of-way line of County Road 231;

Thence S.00°00'W. a distance of 503.81 feet to a spike, passing thru an iron pin in the North right-of-way line of C.R. 150 at a distance of 478.81 feet;

Thence N.89°55'E. along the South line of Section 27, Union Township and the centerline of C.R. 150 a distance of 350.50 feet to a monument box which was the PLACE OF BEGINNING.

Containing 4.041 acres of which 0.529 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements. Previous deed reference: Vol.244, Pg.492. The above plat is recorded in Survey Book E, Page 59, in the Auglaize County Engineer's Office.
