

Thence NO2° 30 W along the centerline of State Route 65 a distance of room. 66 feet to a P.K. Nail and the PLACE OF BEGINNING for the parcel of land herein described.

Thence continuing N 02° 30° W on a foward tangent a distance of 325.67 feet to an iron pipe marking the P.I. at Sta. 509+ 94.07.


