The following described tract of land is part of the Northeast Quarter of Section 7, Clay Township, Town 6 South, Range 7 East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Northeast Quarter of Section 7, Clay Township and in the centerline of County Road 201, (formerly known as the Ashburn Road);
 Thence N. 00° 00' E. along the centerline of County Road 201, and the East Section line of Section 7, Clay Township, a distance of 1002.00 feet to a spike, which is the PLACE OF BEGINNING;
 Thence continuing N. 00° 00' E. along the centerline of C.R. 201 and the East line of Section 7, Clay Township, a distance of 396.00 feet to a spike;
 Thence N. 90° 00' W. a distance of 330.00 feet to an iron pin, passing thru an iron pin at 25.00 feet in the West right-of-way line of County Road 201;
 Thence S. 00° 00' W. a distance of 396.00 feet to an iron pin;
 Thence S. 90° 00' E. a distance of 330.00 feet to a spike, passing thru an iron pin at 305.00 feet in the West right-of-way line of County Road 201, said spike was the PLACE OF BEGINNING.
