Commencing at a monument box at the Northwest corner of Section 4, Washington Township and in the centerline of County Road 91; thence with an assumed bearing of S.00°00'E. along the centerline of County Road 91 and the West line of Section 4, Washington Township, a distance of 50.00 feet to a spike which is the PLACE OF BEGINNING;

thence continuing S.00°00'E. along the centerline of County Road 91 and the West line of Section 4, Washington Township, a distance of 313.33 feet to a spike;

thence N.89°02'E. a distance of 740.00 feet to an iron pin, passing thru an iron pin at 25.00 feet in the East right-of-way line of County Road 91;

thence N.00°00'W. a distance of 313.33 feet to an iron pin;

thence S.89°02'W. along the South right-of-way line of an abandoned Railroad line for a distance of 740.00 feet to a spike, passing thru an iron pin at 715.00 feet in the East right-of-way line of County Road 91, said spike was the PLACE OF BEGINNING.
