

The following described parcel of land is situated in the Southeast quarter of Section Twenty-five (25), Township six South - Range four East, St. Marys Township, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a R.R. spike set over the stone found by the County Engineer at the Southeast corner of said quarter at the intersection of the centerline of East Shelby Road with the centerline of Southland Road; thence South eighty-nine degrees fifty minutes thirty-five seconds West (S 89°-50'-35" W) on the South line of said quarter and the centerline of Southland Road, a distance of one thousand three hundred thirty-five and forty hundredths (1,335.40) to a PK nail set at the Southwest corner of the East half of said quarter; thence North zero degrees seven minutes forty-one seconds East (N 00°-07'-41" E) on the West line of the East half of said quarter, a distance of two hundred twenty-two and sixty-two hundredths (222.62) feet to a PK nail set in the centerline of New Bremen-New Knoxville Road at the PLACE OF BEGINNING; thence continue North zero degrees seven minutes forty-one seconds East (N 00°-07'-41" E) on the West line of the East half of the said quarter; a distance of one thousand one hundred eleven and eighty-two hundredths (1,111.82) feet to a ½" rerod set; thence South eighty-nine degrees thirty-four minutes three seconds East (S 89°-34'-03" E), a distance of five hundred seventy-eight and eleven hundredths (578.11) feet to a ½" rerod set; thence South sixty-four degrees fifty-four minutes thirty-five seconds East (S 64°-54'-35" E), a distance of two hundred twenty-five and eighty-eight hundredths (225.88) feet to a PK nail set in the centerline of New Bremen-New Knoxville Road; thence South twenty-four degrees fifty-nine minutes forty-two seconds West (S 24°-59'-42" W) on the centerline of the road, a distance of one hundred sixty-two and ninety-one hundredths (162.91)ft. to a 2" rerod set; thence South thirty-nine degrees thirty-nine minutes thirty-six seconds West (S 39°-39'-36" W) on the centerline of the road, a distance of one thousand one hundred twenty-two and thirty-three hundredths (1,122.33) feet to the PLACE OF BEGINNING, containing eleven and fifteen hundredths (11.15) acres, more or less, subject to legal highway and all easements of record.
