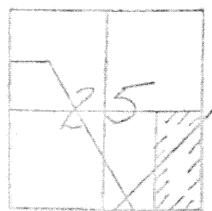

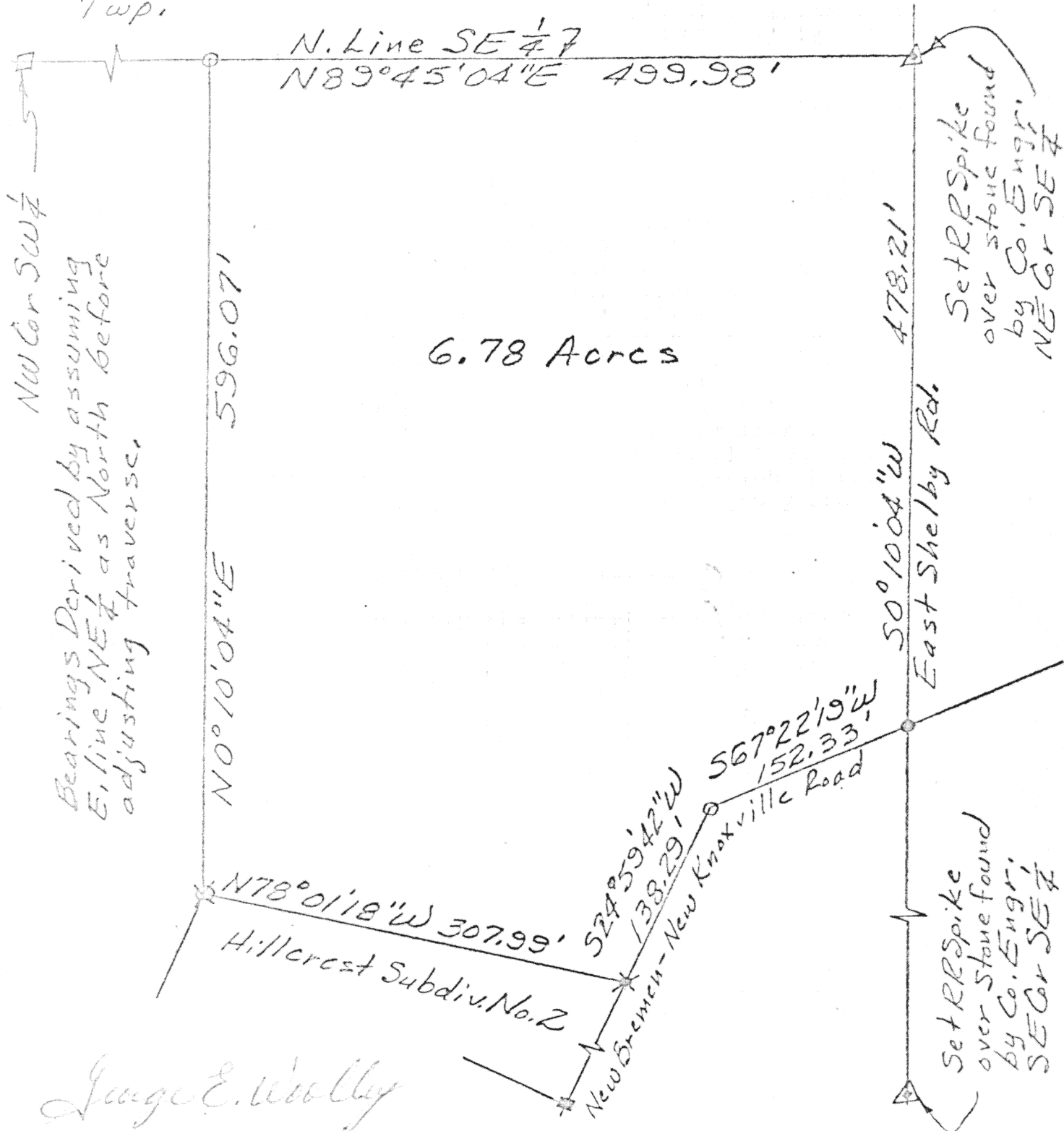

The following described parcel of land is situated in the Southeast quarter of Section Twenty-five (25), Township six South - Range four East, St. Marys Township, Auglaize County, Ohio, and is more particularly described as follows:



Beginning at a R.R. spike set over the stone found by the County Engineer at the Northeast corner of said quarter; thence South zero degrees ten minutes four seconds West (S 00°-10'-04" W) on the East line of said quarter and the centerline of East Shelby Road a distance of four hundred seventy-eight and twenty-one hundredths (478.21) feet to a PK nail set in the centerline of New Bremen-New Knoxville Road; thence South sixty-seven degrees twenty-two minutes nineteen seconds West (S 67°-22'-19" W) on the centerline of New Bremen-New Knoxville Road a distance of one hundred fifty-two and thirty-three hundredths (152.33) feet to a ½" rerod set; thence South twenty-four degrees fifty-nine minutes forty-two seconds West (S 24°-59'-42" W) on the centerline of New Bremen-New Knoxville Road a distance of one hundred thirty-eight and twenty-nine hundredths (138.29) feet to a R.R. spike found at the Northeast corner of Hillcrest Subdivision No. 2; thence North seventy-eight degrees one minute eighteen seconds West (N 78°-01'-18" W) on the North line of the subdivision a distance of three hundred seven and ninety-nine hundredths (307.99) feet to an iron pipe found at the Northwest corner of said subdivision; thence North zero degrees ten minutes four seconds East (N 00°-10'-04" E) a distance of five hundred ninety-six and seven hundredths (596.07) feet to a ½" rerod set in the North line of said quarter; thence North eighty-nine degrees forty-five minutes four seconds East (N 89°-45'-04" E) on the North line of said quarter a distance of four hundred ninety-nine and ninety-eight hundredths (499.98) feet to the PLACE OF BEGINNING, containing six and seventy-eight hundredths (6.78) acres, more or less, subject to legal highway and all easements of record.
