SURVEYORS DESCRIPTION

The following described tract of ground is part of Section 2, Union Township, Township Five (5) South, Range Seven (7) East with respect to the First Principle Meridian, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northeast corner of Section 2, Union Township; said box being in the intersection of the centerlines of Township Road # 241 (T.R. # 241 formerly known as the Graham Rd.) and Township Road # 200 (T.R. # 200 formerly known as the Allen-Union-Wayne Rd.); Thence S89°-32'-40"W along the North line of Section 2 and the centerline of T.R. # 200 a distance of 1072.07 feet to a spike in the West right-of-way line of an abandoned railroad, said spike being the PLACE OF BEGINNING;

Thence continuing S89°-32'-40"W along said centerline and the North line of Section 2 a distance of 1353.41 feet to a spike;

Thence S00°-35'-50"E a distance of 907.50 feet to an iron pin;

Thence S89°-32'-40"W a distance of 240.00 feet to an iron pin in the North-South half-section line of Section 2;

Thence S00°-35'-50"E along said half-section line a distance of 406.66 feet to a stone;

Thence S89°-34'-20"W a distance of 1329.58 feet to a wooden endpost;

Thence S00°-34'-40"E a distance of 1973.67 feet to a 6" steel post;

Thence N89°-43'-30"E a distance of 2664.61 feet to an iron pin;

Thence N00°-15'-40"W a distance of 667.12 feet to an iron pin in the East-West half-section line of Section 2;

Thence N00°-52"W a distance of 993.52 feet to a concrete endpost;

Thence N89°-37'-20"E a distance of 1334.91 feet to a spike in the centerline of T.R. # 241 and the East line of Section 2;

Thence N00°-30"W along said centerline and the East line of Section 2 a distance of 92.89 feet to a spike, said spike being in the West right-of-way line of an abandoned railroad line;

Thence N35°-15'-40"W along said right-of-way line a distance of 1580.55 feet to a spike in the North line of Section 2 and the PLACE OF BEGINNING.

The above described tract of ground contains 157.11<sup>1/4</sup> Acres of which 0.670 Acres has been dedicated for highway purposes. The above described tract of ground is subject to all easements of record. Previous deed reference, Volume 4, Page 508, Auglaize County Recorders Office. Survey filed in Plat Book F, Page 231, Auglaize County Engineers Office.
