The following described parcel of ground is part of the East half of Section 5, Logan Township, Township Five (5) South, Range Five (5) East, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of Section 5, Logan Township; Thence N88°-00'W along the south line of Section 5 a distance of 570.96 feet to a spike in the centerline of Township Road # 89 (T.R. # 89 known as the Mitchell Road) and the PLACE OF BEGINNING;

Thence continuing N88°-00'W along the south line of Section 5 a distance of 553.19 feet to an iron pin;

Thence N02°-17'-30"E a distance of 2430.83 feet to a P.K. Nail in the centerline of State Route # 197;

Thence S76°-08'E along the centerline of State Route # 197 a distance of 841.24 feet to a P.K. Nail;

Thence S35°-00'-40"E a distance of 487.33 feet to an iron pin in the centerline of County Road # 91 (C.R. # 91 formerly known as the Moulton Ft. Amanda Road) and the East line of Section 5;

Thence S02°-09'W along the centerline of C.R. # 91 and the East line of Section 5 a distance of 912.84 feet to a spike;

Thence S54°-34'W a distance of 185.91 feet to an iron pin;

Thence S65°-41'W a distance of 300.30 feet to an iron pin;

Thence S31°-17'W a distance of 61.42 feet to an iron pin;

Thence S23°-34'E a distance of 1.31 feet to an iron pin;

Thence N88°-00'W a distance of 26.76 feet to an iron pin;

Thence S26°-01'-30"W a distance of 263.50 feet to an iron pin;

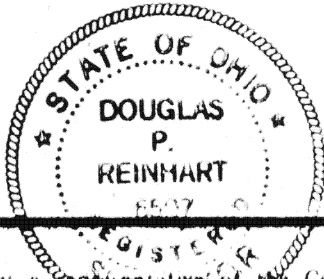
Thence S03°-32'-30"W a distance of 149.35 feet to an iron pin;

Thence S27°-03'-30"E a distance of 53.34 feet to an iron pin;

Thence S52°-12'-20"E a distance of 120.31 feet to a spike in the centerline of Township Road # 89;

Thence S39°-00'-30"W a distance of 185.32 feet along the centerline of T.R. # 89 to a spike and the PLACE OF BEGINNING.

The above described tract of ground contains 48.76 Acres of which 1.19 Acres has been dedicated for highway purposes. Previous deed references: Volume 141, Page 136 and Volume 211, Page 216, Auglaize County Recorders Office. Survey filed in plat Book E, Page 303, Auglaize County Engineers Office. All bearings based upon the centerline survey by the Ohio Department of Transportation of State Route # 197. Original corner monuments were found on the adjacent parcels as described in Volume 155, Page 522, of the recorders office. The bearings and dimensions given above are the actual field dimensions due to the error in the previous survey of the said adjacent parcel.
