


Description of part of Outlot fifteen in the city of Wapakoneta, Ohio Auglaize County, Ohio and being further described as follows.

Commencing at the north/east corner of lot 1543 of Franklin Addition in the city of Wapakoneta, Ohio also being a point on the west Right-of-Way of Highland Street and a point on the south line of a sixteen and a half foot alley, said corner being marked by a iron pipe.

Thence in a westerly direction along the north line of Lot 1543 and the south line of a sixteen and a half foot alley a distance of 75.08 feet to the north/east corner of Outlot fifteen in the city of Wapakoneta, Ohio, also being the PLACE OF BEGINNING for the parcel herein described.

Thence continuing along the north line of Outlot fifteen and the south line of a sixteen and a half foot alley a distance of twenty feet (20.0) to a iron pipe.

Thence in a southerly direction with a angle to the right being a interior angle to this parcel of $91^{\circ}48'$ a distance of 47.32 feet to a iron pipe.

Thence in a northeasterly direction with an interior angle of $22^{\circ}38'$ a distance of 51.94 feet to the north/east corner of Outlot fifteen of the city of Wapakoneta, Ohio, also being a point on the south line of a sixteen and a half foot alley, also being the PLACE OF BEGINNING for this parcel.
