Thence N69°-55'-40"E's distance of 1621.86 feet to an iron pin; Thence NOO°-08'-30"W a distance of 104/.10 feet to an iron pin;

Thence NS9°-58'E a distance of 828.00 feet to an iron pin in the east line of the Northwest Quarter of Section 26;

Thence SOO"-08'-30"E along the east line of said quarter section a distance of 1825.29 feet to an iron pin at the Southeast corner of the Northwest Quarter of Section 26, Salem Township;

The nee S89°-55'-40"W along the south line of said quarter section a distance of 2651.82 feet to a monument box and the PLACE OF BEGINNING.
