

DESCRIPTION:

Feing a parcel of land situated in the northeast quarter of Section 31, T 4 S,

R 4 E, Sales Township, Auglaize County, Ohio, and more fully described as follows:


Recinning at a point (said point lies on the east line of the northeast quarter of Section 31 marked by a stone found located W 00° 11' E a distance of 1998.90' from a R.R. Spike found marking the southeast corner of the northeast quarter of Section 31;

- (1) thence continuing N 000 111 E along the east line of the northeast quarter of Section 31 for a distance of 387.30' to a point on the centerline of Hesse Road marked by a iron pin set and passing through a iron pin set at 356.21' to mark the southerly right of way line of Hesse Road;
- (2) thence northwesterly along a curve to the left on the centerline of Hesse Road for a distance of 396.08' on the arc to a point marked by a iron pin set; Curve Data:

N 81° 24' W Chord Bearing Chord Length 395.231 Radius 1677.30 Tangent Distance 199.004 039 24 58" Degree of Curve

- (3) thence continuing westerly along the centerline of Hesse Road bearing W 880 101 W for a distance of 80.00' to a point marked by a iron pin set;
- (4) thence continuing westerly along the centerline of Hesse Road bearing N 88° 28' W for a distance of 102.53' to a point marked by a iron pin set;
- thence continuing westerly along the centerline of Hesse Road bearing \$ 870 500 for a distance of 200.00' to a point which is the point of intersection of centerlines for Hesse Road and the Maier Barber Roads marked by a iron pin set;
- thence southeasterly along the centerline of Maier Barber Road bearing S 120 54' E for a distance of 122.40' to a point marked by a iron pin set;
- thence continuing southeasterly along the centerline of Maier Barber Road bearing S 21 08' E for a distance of 352.80' to a point marked by a iron pin set;
- (8) thence easterly bearing N 89° 36' 20" E for a distance of 617.40' to the point of beginning and passing through a iron pin set at 32.12' to mark the easterly right of way line for Maier Barber Road.
