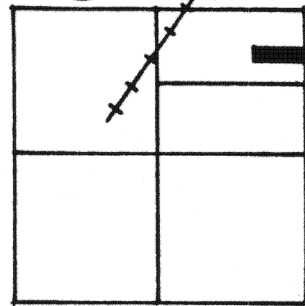

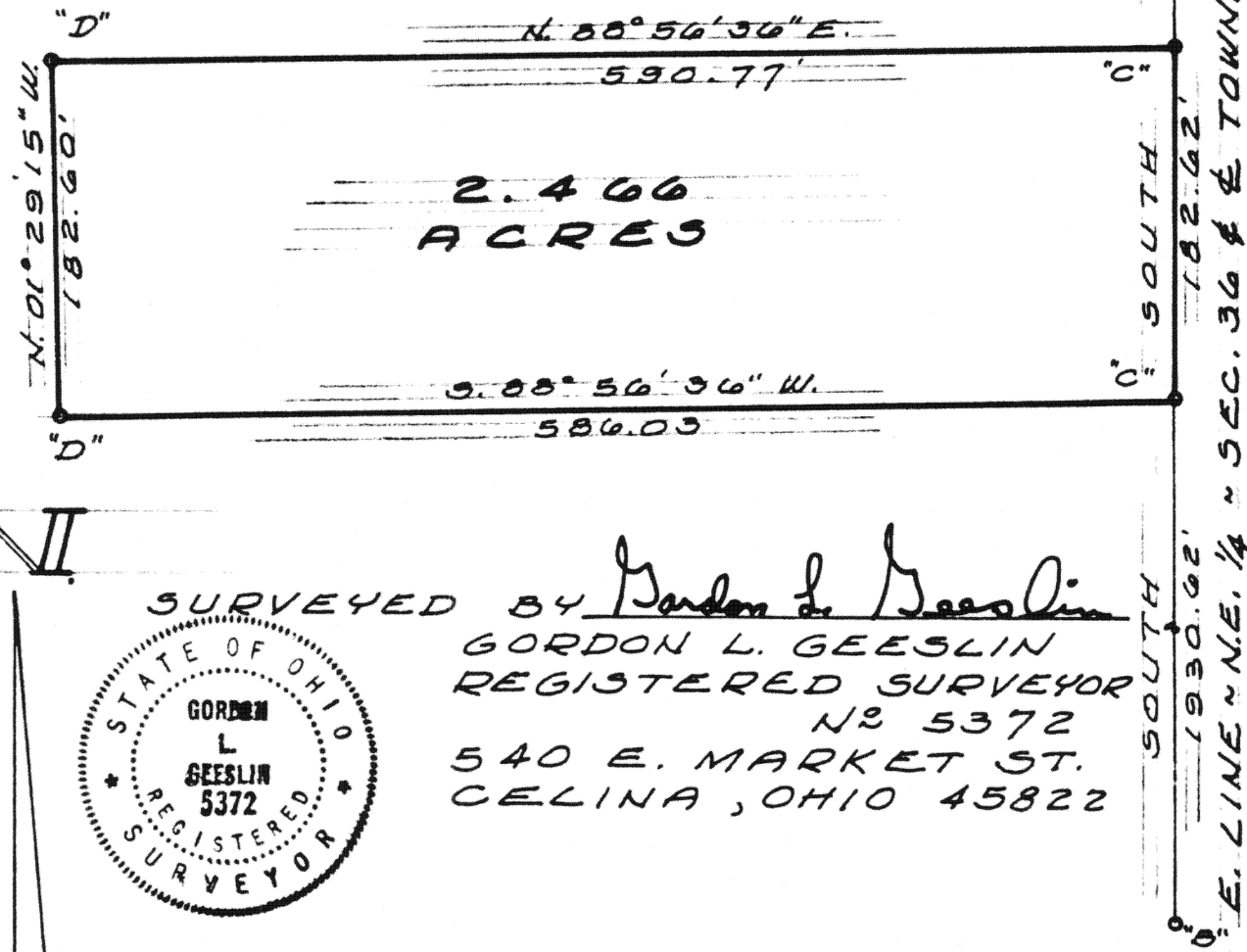
LOCATION SKETCH

CLAUSING SURVEY DESCRIPTION

Being all that part of the north half of the northeast quarter of Section 36, Township 5 South, Range 4 East (Noble Township), Auglaize County, Ohio, that lies southeast of the Norfolk and Western Railroad right-of-way less and except the following-

Being a parcel of land situated in Noble Township, Auglaize County, Ohio, in the north half of the northeast quarter of Section 36, Township 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box at the northeast corner of said Section 36-

Thence, south, along the east line of said northeast quarter of Section 36 and the centerline of Townline-Kossuth Road, a distance of five hundred sixty-one and 78/100 (561.78) feet to a railroad spike. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing south, along the last described line, a distance of one hundred eighty-two and 62/100 (182.62) feet to a railroad spike-

Thence, south 88°56'36" west, a distance of five hundred eighty-six and 03/100 (586.03) feet to a 5/8 inch iron bar-

Thence, north 01°29'15" west, a distance of one hundred eighty-two and 60/100 (182.60) feet to a 5/8 inch iron bar-

Thence, north 88°56'36" east, a distance of five hundred ninety and 77/100 (590.77) feet to the place of beginning.

Containing 2.466 acres of land more or less in said exception.

The tract being transferred contains 62.135 acres more or less after all exceptions and subject to all other easements and right-of-way of record.

Reference is made to surveys of this area by Gordon L. Geeslin, Registered Surveyor 5372, dated December, 1980, and Michael Weadock, Registered Surveyor 6199, dated April, 1979, on file in the County Engineer's Office.
