

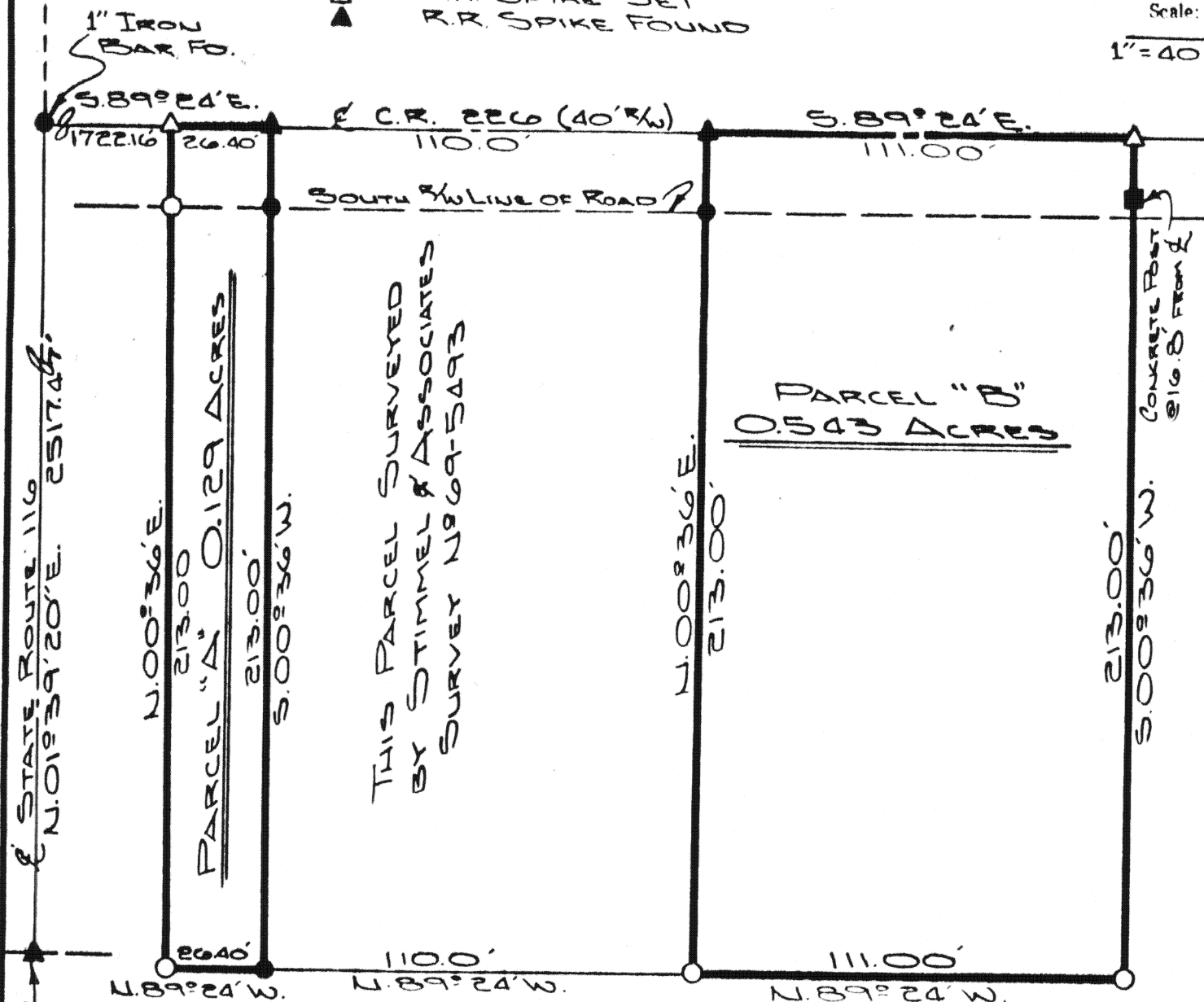

SURVEYORS DESCRIPTION



The following described parcels of ground are part of the Southwest Quarter of Section 21, Salem Township, Township Four (4) South, Range Four (4) East, Auglaize County, Ohio and are more particularly described as follows:

PARCEL "A" 0.129 ACRES

Commencing at a spike over a stone at the Southwest corner of Section 21, Salem Township, said stone being in the centerline of State Route # 116; Thence N01°-39'-20"E along the centerline of State Route # 116 a distance of 2517.47 feet to an iron bar at the intersection of the centerline of County Road # 226 (C.R. # 226 formerly known as the Deep Cut Road); Thence S89°-24'E along the centerline of C.R. # 226 a distance of 1722.16 feet to a spike and the PLACE OF BEGINNING;

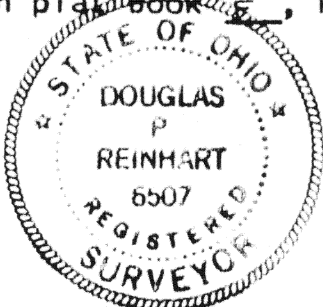
Thence continuing S89°-24'E along said centerline a distance of 26.40 feet to a spike;

Thence S00°-36'W through an iron pipe at 20.00 feet for a total distance of 213.00 feet to an iron pipe;

Thence N89°-24'W a distance of 26.40 feet to an iron pin;

Thence N00°-36'E through an iron pin at 193.00 feet for a total distance of 213.00 feet to a spike and the PLACE OF BEGINNING.

Commencing at a spike over a stone at the Southwest corner of Section 21, Salem Township, said stone being in the centerline of State Route # 116; Thence N01°-39'-20"E along the centerline of State Route # 116 a distance of 2517.47 feet to an iron bar at the intersection of the centerline of County Road # 226 (C.R. # 226 formerly known as the Deep Cut Road); Thence S89°-24'E along the centerline of C.R. # 226 a distance of 1858.56 feet to a spike and the PLACE OF BEGINNING;

Thence continuing S89°-24'E along said centerline a distance of 111.00 feet to a spike;

Thence S00°-36'W through a concrete post at 16.8 feet for a total distance of 213.00 feet to an iron pin;

Thence N89°-24'W a distance of 111.00 feet to an iron pin;

Thence N00°-36'E through an iron pipe at 193.00 feet for a total distance of 213.00 feet to a spike and the PLACE OF BEGINNING.

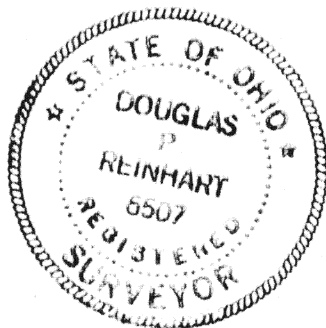
