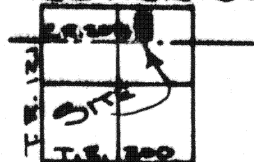


# LOCATION PLAN

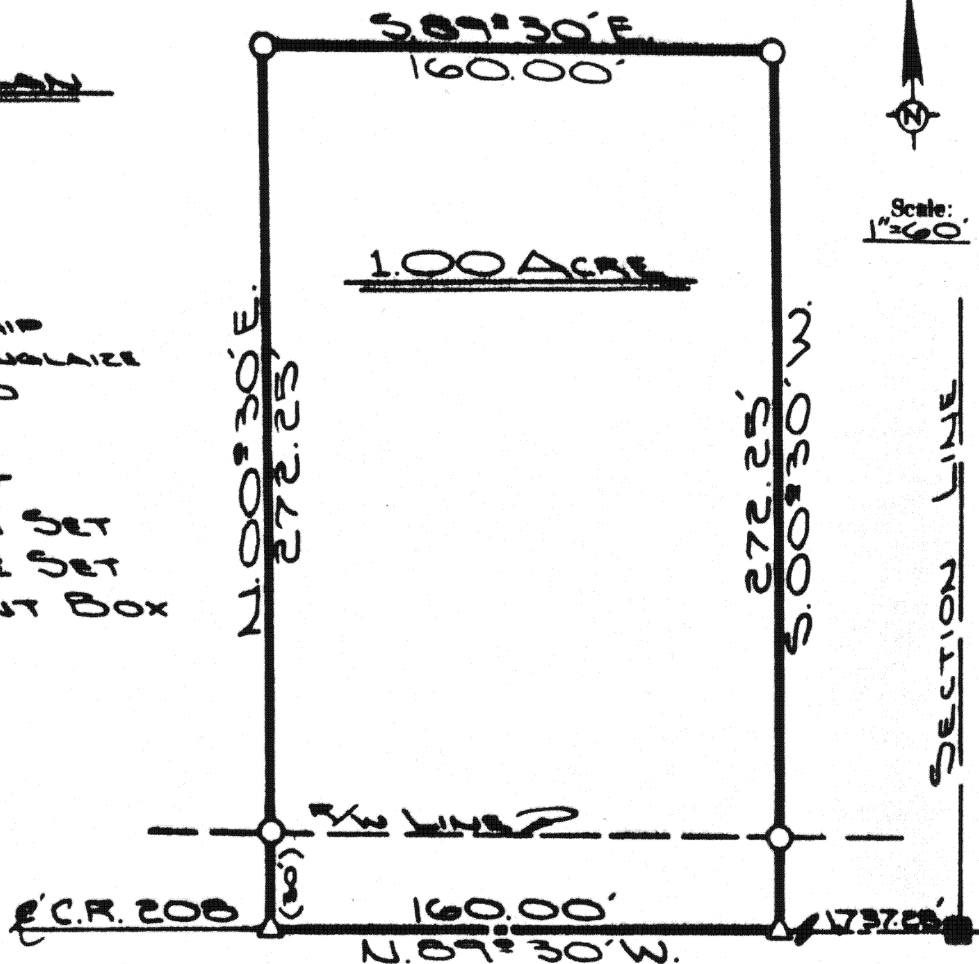
SECTION 36

The following described tract of land is part of the  $\frac{1}{4}$  Fraction of Section 36, Logan Township, Town 4 South, Range 5 East, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box on the East line of Section 36 and the centerline of County Road 208, formerly known as the National Road;

Thence N.89°30'W. along the centerline of County Road 208 a distance of 1737.28 feet to a spike which is the PLACE OF BEGINNING;

Thence continuing N.89°30'W. a distance of 160.00 feet to a spike;

Thence N.00°30'E. a distance of 272.25 feet to an iron pin, passing thru an iron pin at 30.00 feet in the North right-of-way line of County Road 208;

Thence S.89°30'E. a distance of 160.00 feet to an iron pin;

Thence S.00°30'W. a distance of 272.25 feet to a spike, passing thru an iron pin at 242.25 feet in the North right-of-way line of County Road 208, said spike was the PLACE OF BEGINNING.

Containing 1.00 Acre of which 0.11 Acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements of record. Previous deed reference: Volume 2, Page 313. This Survey is recorded in Survey Book F, Page 234 in the Auglaize County Engineer's Office. The bearing of N.89°30'W. on County Road 208 is an assumed bearing.
