Thence continuing SO6 -13'E a distance of 69.00 feet to an iron pin;

Thence \$83°-47'W a distance of 107.25 feet to an iron pin in the

East line of an 16.50' alley; Thence S06 -13'E along said alley a distance of 18.12 feet to an iron pin in the South Line of Outlot # 42; Thence N83 -45'E along said outlot line a distance of 262.24 feet
