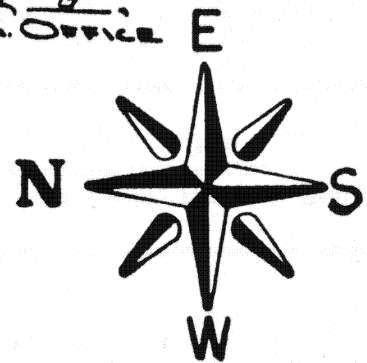
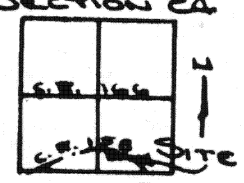


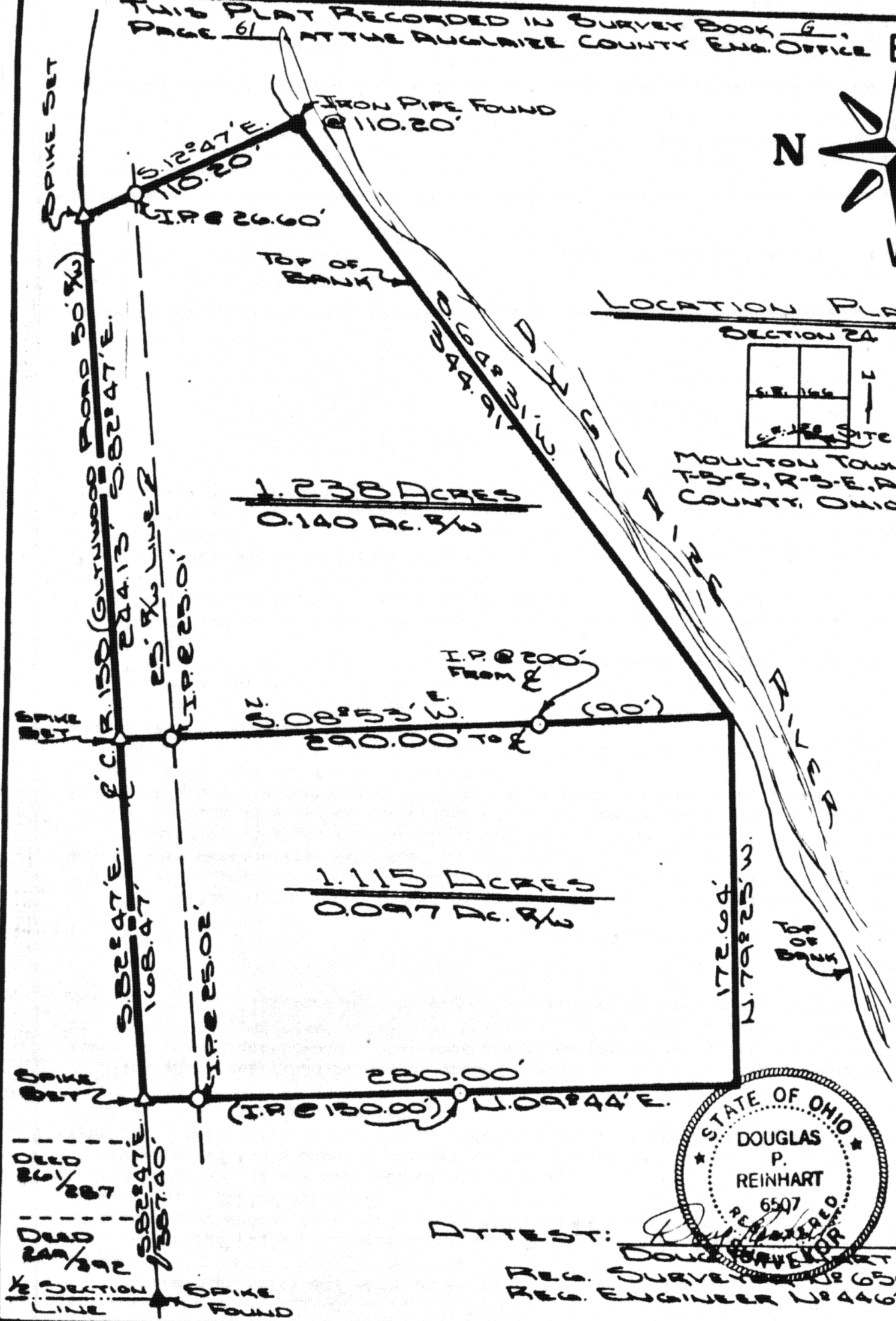

1.115 ACRES

The following described parcel of ground is part of the Southeast Quarter of Section 24, Moulton Township, Township Five South, Range Five East, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a railroad spike at the intersection of the North-South half-section line of Section 24 and the centerline of County Road # 158 (Glynwood Road); Thence S 82°-47'E along the centerline of C.R. # 158 a distance of 387.40 feet to a spike and the PLACE OF BEGINNING;

Thence continuing S 82°-47'E along said centerline a distance of 168.47 feet to a spike;

Thence S 08°-53'W passing through an iron pin at 25.01 feet, and passing through an iron pin at 200.00 feet for a total distance of 290.00 feet to the top of the bank of the Auglaize River;

Thence N 79°-25'W a distance of 172.64 feet;

Thence N 09°-44'E passing through an iron pin at 130.00 feet and a pin at 254.98 feet for a total distance of 280.00 feet to a spike in the centerline of County Road # 158 and the PLACE OF BEGINNING.

Thence S 12°-47'E through an iron pin at 26.60 feet for a total distance of 110.20 feet to an iron pin on the north bank of the Auglaize River;

Thence S 64°-31'W along the north bank of the Auglaize River a distance of 344.91 feet;

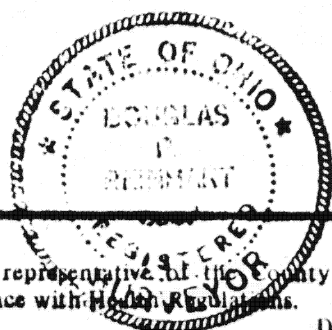
