

The following described tract of land is part of the Northwest Quarter of Section 35, Union Township, Town 5 South, Range 7 East, Auglaize County, Ohio, and is more particularly described as follows:

The PLACE OF BEGINNING is a monument box at the Southwest corner of the Northwest Quarter of Section 35, Union Township;
Thence with an assumed bearing of N.00°00'E., along the centerline of County Road 231 and the west line of Section 35, Union Township a distance of 1290.00 feet to a spike;
Thence N.89°37'30"E. a distance of 1350.75 feet to a spike;
Thence S.00°00'W. a distance of 1290.00 feet to an iron pin;
Thence S.89°37'30"W. a distance of 1350.75 feet along the south line of the Northwest Quarter of Section 35, Union Township, to the monument box which was the true PLACE OF BEGINNING.

Containing 40.00 Acres of which 0.74 Acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements of record. Previous deed reference: Volume 182, Page 266. This plat is recorded in Survey Book G, Page 79, at the Auglaize County Engineer's Office.
