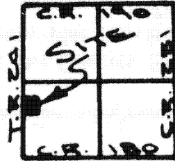


## LOCATION PLAN

## SURVEYORS DESCRIPTION

The following described parcel of ground is part of the Southwest Quarter of Section 12, Union Township, Township Five (5) South, Range Seven (7) East, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northwest Corner of the Southwest Quarter of Section 12, Union Township, said box being in the centerline of Township Road # 241 (Graham Road); Thence S00°-13'-40"E along the West line of Section 12 and the centerline of T.R. # 241 a distance of 330.97 feet to a spike and the PLACE OF BEGINNING;

Thence continuing along said section line and centerline a distance of 660.00 feet to a spike;

Thence N89°-44'-35"E a distance of 335.00 feet to an iron pin;

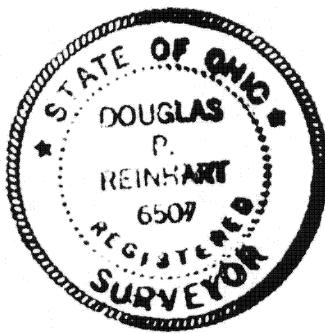
Thence N00°-13'-40"W a distance of 660.00 feet to an iron pin;

Thence S89°-44'-35"W a distance of 335.00 feet to a spike in the West line of Section 12 and the PLACE OF BEGINNING.

The above described parcel of ground contains 5.075 Acres and is subject to 0.35 Acres of road right-of-way. Previous deed reference: Volume 262, Page 112, Auglaize County Records Office. Survey filed in Plat Book G, Page 92, Auglaize County Engineers Office.
