Beginning at a PK.nail found at the intersection of the centerline of County Road 33A with the centerline of Bay Road (T.R. 101); thence S 00°21'18" W with the centerline of said Bay Road, 1167.85 feet to a railroad spike found at the northeast corner of a 5.37 acre tract of land owned by the Vistron Corporation and described in Deed Vol. 236 on Page 798; thence S 89°21'18" W with the north line of said 5.37 acre tract of land, 520.00 feet to a 5/8" rebar set at the northwest corner of said tract; thence S 00°12'06" W with the west line of said 5.37 acre tract of land, 550.00 feet to a 5/8" rebar set at the southwest corner of said 5.37 acre tract of land, said point being on the south line of said Section 33, S 89°21'18" W, 160.90 feet from the southeast corner of said Section 33; thence S 89°21'18" W with the south line of said Section 33, 627.39 feet to a 12" wood corner post; thence N 00°05'00" E, 1208.29 feet to a 5/8" rebar set at the southwest corner of a 0.64 acre tract of land described in Deed Vol. 205 on Page 407; thence N 82°14'00" E with the south line of said 0.64 acre tract, 110.00 feet to a 5/8" rebar set at the southeast corner of said tract; thence N 00°01'00" W with the east line of said County Road 33A, thence N 82°14'00" E with the centerline of said County Road 33A, thence N 82°14'00" E, 250.00 feet to a 5/8" rebar set; thence N 82°14'00" E, 397.71 feet to a 5/8" rebar set; thence N 00°01'00" W, 251.99 feet to the centerline of said County Road 33A; thence N 00°01'00" W, 251.99 feet to the centerline of said County Road 33A; thence northeasterly with the said centerline on a curve to the left having a radius of 27,722.08 feet an arc length of 424.48 feet to the FT. of said curve (chord for said curve is N 81°07'19" E, 424.48 feet); thence N 80°41'00" E, 5.71 feet to the FLACE OF BEGINNING containing 32.320 acres more or less. 9.434 acres are in the Southwest currer of Section 34 and 22.886 acres are in the Southeast quarter of
