
Commencing at a P.K. nail (found) at the Southeast corner of said Northeast quarter; thence N Ol° 15' 00" W, 837.72 feet, with the East line of said Northeast quarter (centerline of Wrestle Creek Road), to a mine spike (set) at the PLACE OF BEGINNING; thence S 88° 50' 00" W, 248.91 feet to an iron pipe (set); thence N Ol° 15' 00" W, 350.00 feet, parallel to the East line of said Northeast quarter (centerline of Wrestle Creek Road), to an iron pipe (set); thence N 88° 50' 00" E, 248.91 feet to a mine spike (set) on the East line of said Northeast quarter (centerline of Wrestle Creek Road); thence S Ol° 15' 00" E, 350.00 feet, with said East line (centerline of Wrestle Creek Road), to the PLACE OF BEGINNING, containing 87,120 square feet or 2.000 acres more or less and subject to all legal highways, easements, and restrictions of record.

PARCEL NO. 2

Being a parcel of land situate in the Northeast quarter of Section 34, T-5-S, R-7-E, Union Township, Auglaize County, Ohio, and being more particularly described as follows:

Commencing at 3 P.K. nail (found) at the Southeast corner of said Northeast quarter; thence N O1° 15' 00" W, 676.93 feet, with the East line of said Northeast quarter (centerline of Wrestle Creek Road), to a P.K. nail (found) at the PLACE OF BEGINNING; thence S 88°50' 00" W, 350.00 feet to an iron pin (found); thence N O1°15' 00" W, 622.29 feet, parallel to the East line of said Northeast quarter (centerline of Wrestle Creek Road), to an iron pin (found); thence N 88° 50' 00" E, 350.00 feet to a P.K. nail (found) on the East line of said Northeast quarter (centerline of Wrestle Creek Road); thence S O1° 15' 00" E, 111.50 feet, with said East line (centerline of Wrestle Creek Road), to a mine spike (set); thence S 88° 50' 00" W, 248.91 feet to an iron pipe (set); thence S 01°15' 00" E, 350.00 feet, parallel to the East line of said Northeast quarter (centerline of Wrestle Creek Road), to an iron pipe (set); thence N 88° 50' 00" E, 248.91 feet to a mine spike (set) on the East line of said Northeast quarter (centerline of Wrestle Creek Road); thence S 01° 15' 00" E, 160.79 feet, with said East line (centerline of Wrestle Creek Road), to the PLACE OF BEGINNING, containing 130,681 square feet or 3.000 acres more or less and subject to all legal highways, easements, and restrictions of record.
