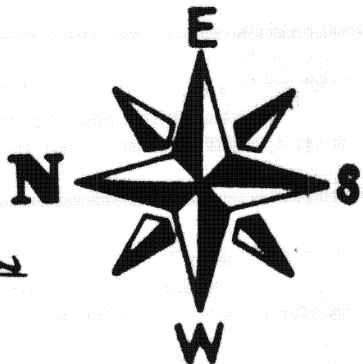
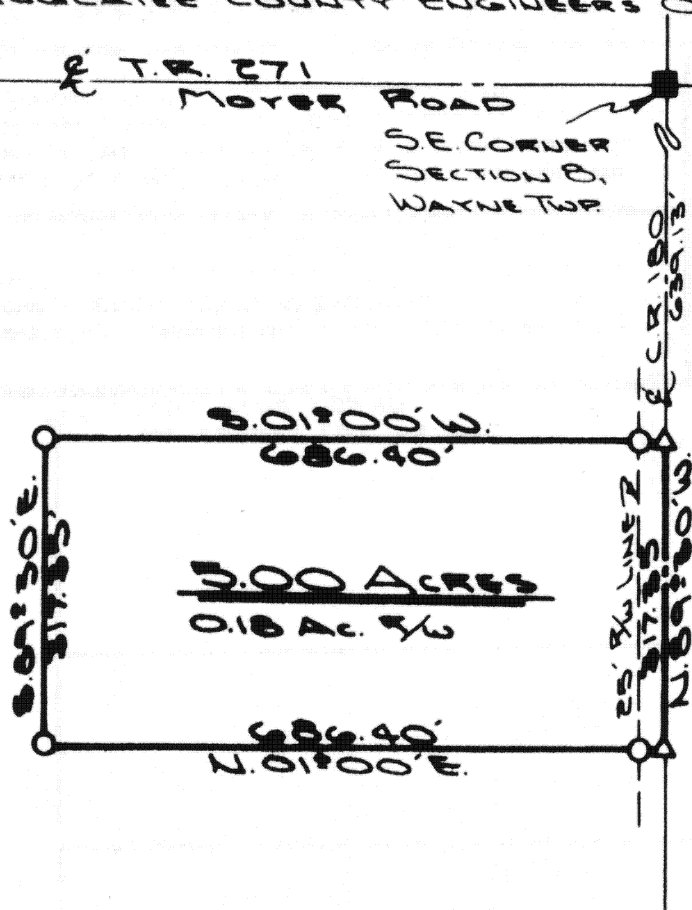


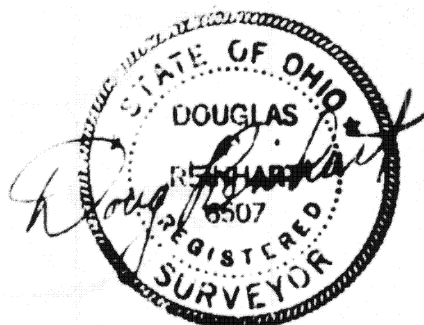

SURVEYORS DESCRIPTION

The following described parcel of ground is part of the Southeast Quarter of Section 8, Wayne Township, Township Five South, Range Eight (8) East, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the southeast corner of Section 8, Wayne Township, said box being in the centerline of County Road # 180, Fairmont Road; Thence with an assumed bearing of N89°-30'W a distance of 639.13 feet along the south line of section 8 and the centerline of County Road # 180 to a spike and the PLACE OF BEGINNING;

Thence continuing N89°-30'W along said section line a distance of 317.35 feet to a spike;

Thence N01°-00'E through an iron pin at 25.00 feet in the North right-of-way line of County Road # 180 for a total distance of 686.40 feet to an iron pin;

Thence S89°-30'E a distance of 317.35 feet to an iron pin;

Thence S01°-00'W through an iron pin at 661.40 feet in the north right-of-way line of County Road # 180 for a total distance of 686.40 feet to a spike in the South line of Section 8 and the PLACE OF BEGINNING.

The above described parcel of ground contains 5.00 Acres and is subject to 0.18 Acres of road right-of-ways. Previous deed reference: Volume 195, Page 891, Auglaize County Recorder's Office. Survey filed in Plat Book G, Page 231 of the Auglaize County Engineer's Office.
