

## SURVEYORS DESCRIPTION 124.561 ACRE PARCEL

The following described parcel of ground is part of the Southwest

Quarter of Section 14 and the Southeast Quarter of Section 15, German Township,

Township Seven South, Range Four East, Auglaize County, Ohio and is more particularly described as follows:

THE PLACE OF BEGINNING is a monument box at the Southwest corner of Section 14, German Township, said box being in the centerline of County Road # 50, Amsterdam Road, Thence N00°-33'-40"W along the West line of Section 14 a distance of 1109.19 feet to an iron pin;

Thence S89°-33'-20"W a distance of 525.64 feet to a P.K. Nail in the centerline of State Route # 66 at Station 171+95.52 of the Ohio Department of Transportation right-of-way plans;

Thence  $N06^{\circ}-29^{\circ}-20^{\circ}W$  along the centerline of State Route # 66 a distance of 852.75 feet to a P.K. Nail at Station 180+48.27:

Thence N89°-44'-20"E along the south line of the Scheer Subdivision of the Village of New Bremen a distance of 613.71 feet to a concrete monument in the East line of Section 15;

Thence S00°-33'-40"E along the East line of Section 15 a distance of 83.62 feet to a concrete monument;

Thence N88°-46'-30"E along the south line of South Haven Subdivision and Dicke Subdivision a distance of 825.32 feet to a concrete monument;

Thence N88°-42'E a distance of 1826.09 feet to an 8" wooden endpost;

Thence S00°-00'W a distance of 1871.54 feet to a monument box at the Southeast corner of the Southwest Quarter of Section 14, said box also being in the center-line of County Road # 50, Amsterdam Road;

Thence S88°-42'-50"W along the South line of Section 14 and the centerline of County Road # 50 a distance of 2633.10 feet to a monument box and the PLACE OF BEGINNING.

Thence NO6°-29'-20"W along the centerline of State Route # 66 a distance of 256.94 feet to a P.K. Nail at Station 171+95.52;

Thence N89°-33'-20"E a distance of 525.64 feet to an iron pin in the East line of Section 15;

Thence S00°-33'-40"E along the East line of Section 15 a distance of 255.28 feet to a concrete monument and the PLACE OF BEGINNING.
