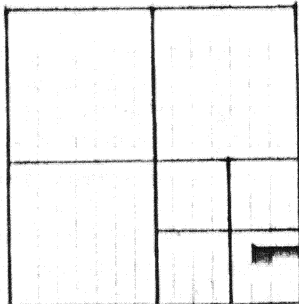
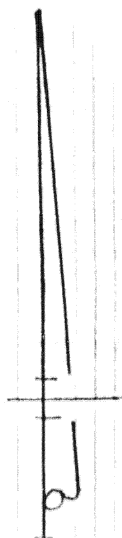


LOCATION SKETCH

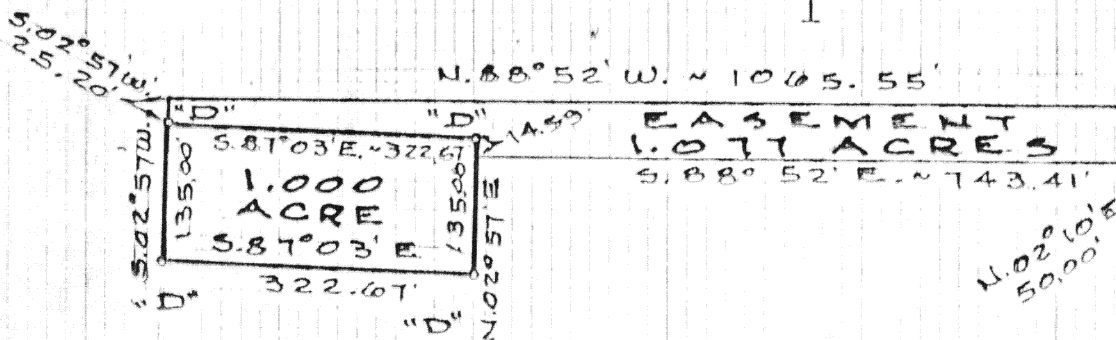

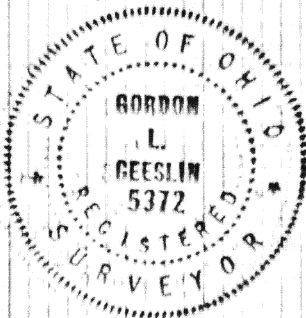


N. 02° 10' E. ~ 1755.94' B

Thence, north 88°52' west, a distance of one thousand sixty-five and 55/100 (1065.55) feet to a point-

Thence, south 02°57' west, a distance of twenty-five and 20/100 (25.20) feet to a 5/8 inch iron bar. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing south 02°57' west, a distance of one hundred thirty-five (135.00) feet to a 5/8 inch iron bar-

Thence, south 87°03' east, a distance of three hundred twenty-two and 67/100 (322.67) feet to a 5/8 inch iron bar-

Commencing for reference at an iron bar in a monument box at the southeast corner of said Section 29-

Thence, north 02°10' east, along the east line of the southeast quarter of said Section 29 and the centerline of Moulton-Fort Amanda Road, a distance of eight hundred fifty-three and 54/100 (853.54) feet to a railroad spike. Said point being the place of beginning for the herein described easement-

Thence, continuing north 02°10' east, along the last described line, a distance of fifty (50.00) feet to a railroad spike-

Thence, north 88°52' west, a distance of one thousand sixty-five and 55/100 (1065.55) feet to a point-

Thence, south 02°57' west, a distance of twenty-five and 20/100 (25.20) feet to a 5/8 inch iron bar-

Thence, south 87°03' east, a distance of three hundred twenty-two and 67/100 (322.67) feet to a 5/8 inch iron bar-

Thence, south 02°57' west, a distance of fourteen and 59/100 (14.59) feet to a point-

Thence, south 88°52' east, a distance of seven hundred forty-three and 41/100 (743.41) feet to the place of beginning.
