DESCRIPTION

Part of the east half of the southeast quarter of Section 15, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio, described as follows:

Commencing at a found railroad spike with punch hole at the southwest corner of said east half, which point is also the intersection of the centerlines of State Route 67 and Heit Road (a.k.a. Wayne Township Road No. 287); thence N 00° 00' 00" E, with the west line of said east half (centerline of Heit Road) (assumed basis of bearings for this survey), a distance of 581.20 feet, to a set railroad spike with punch hole, which is the POINT OF BEGINNING (also, this point is 2065.24 feet southerly from a set one-inch iron pipe over a found one-half inch rebar at the northwest corner of said east half); thence continuing N 00° 00' 00" E, with the west line of said east half (centerline of Heit Road), a distance of 140.00 feet, to a set railroad spike with punch hole; thence N 90° 00' 00" E, entering into said east half at a right angle to the previous course, a distance of 311.14 feet, to a set one-inch iron pipe (this course passes a set one-inch iron pipe at 30.00 feet); thence S 00° 00' 00" W, parallel to the west line of said east half (centerline of Heit Road), a distance of 140.00 feet, to a set one-inch iron pipe; thence S 90° 00' 00" W, at a right angle to the previous course, a distance of 311.14 feet, to the POINT OF BEGINNING (this course passes a set one-inch iron pipe at 281.14 feet, being 30.00 feet easterly from the centerline of Heit Road). This parcel contains 43560 square feet (1.000 acre), subject to all legal highways and easements or other restrictions of record.
