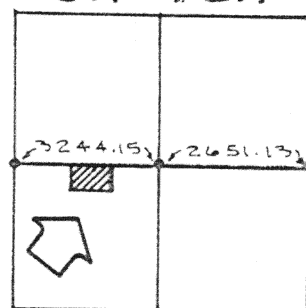

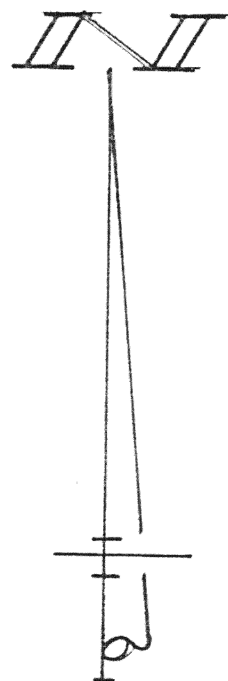
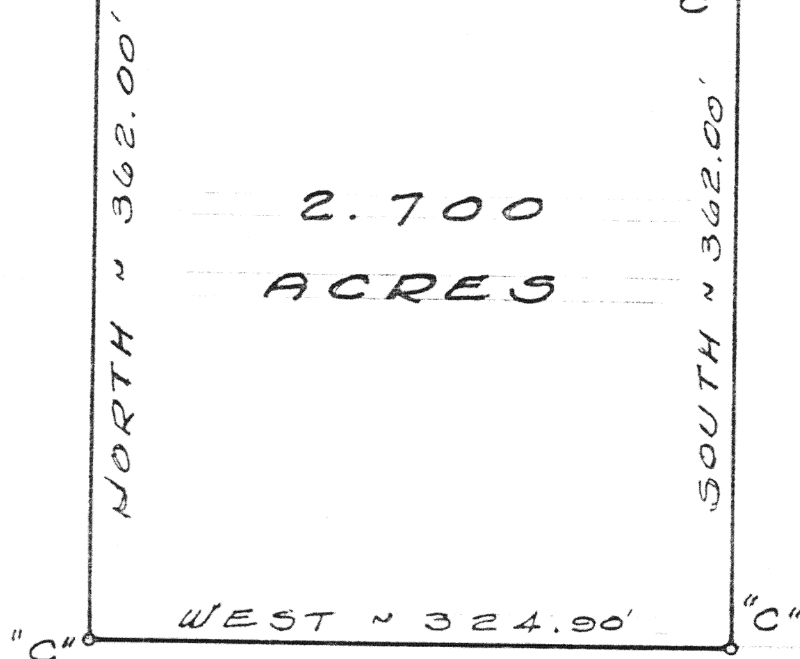

ZIMMERMAN SURVEY DESCRIPTION

Being a parcel of land situated in Logan Township, Auglaize County, Ohio, in the southwest quarter of Section 30, Township 4 South, Range 5 East. Being more particularly described as follows:

Commencing for reference at the corner stone at the northwest corner of said southwest quarter of Section 30-

Thence, east, along the north line of said southwest quarter of Section 30 and the centerline of Logan Township Road 216-A, a distance of one thousand nine hundred ninety-five and 99/100 (1995.99) feet to a railroad spike. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing, east, along the last described line, a distance of three hundred twenty-four and 90/100 (324.90) feet to a 5/8 inch iron bar-

Thence, south, a distance of three hundred sixty-two (362.00) feet to a 5/8 inch iron bar-

Thence, west, a distance of three hundred twenty-four and 90/100 (324.90) feet to a 5/8 inch iron bar-

Thence, north, a distance of three hundred sixty-two (362.00) feet to the place of beginning.

Containing 2.700 acres of land more or less.

Subject to all easements and right-of-way of record.
