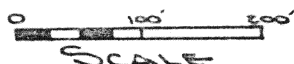

SECTION 18

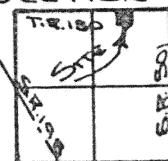

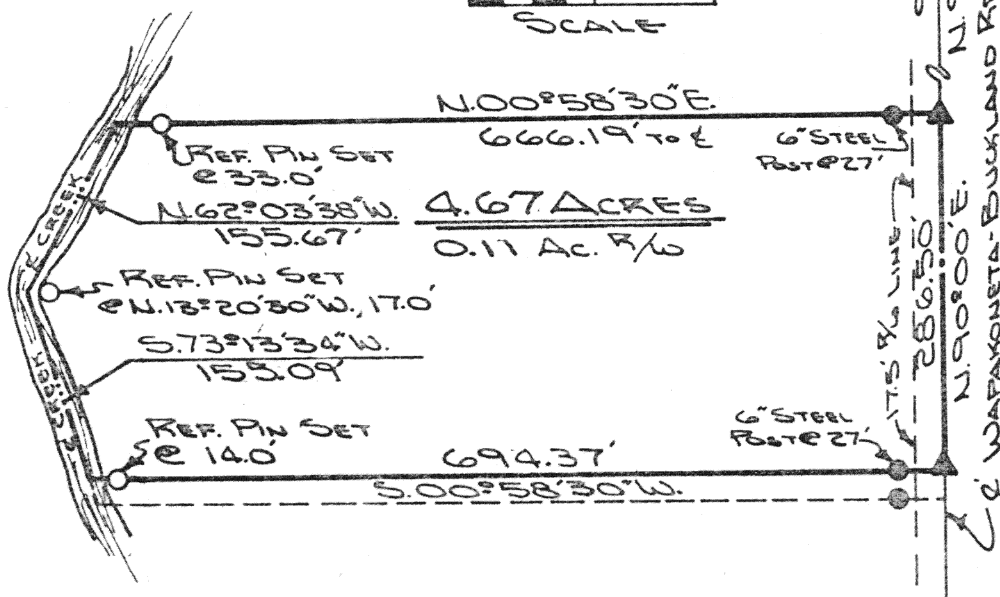
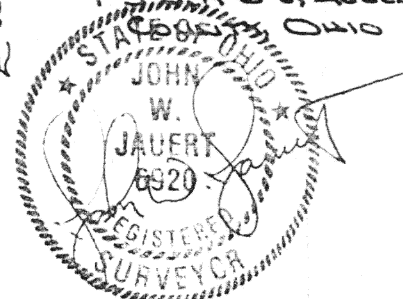


LOCATION PLAN

T. 5 S. R. 6 E, AUGLAIZE
COUNTY, OHIO



The following described tract of land is part of the Northwest Quarter of the Northeast Quarter of Section 18, Duchouquet Township, Town 5 South, Range 6 East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at the Section Stone at the Northwest corner of the Northeast Quarter of Section 18, Duchouquet Township;

thence with an assumed bearing of N.90°00'E. along the centerline of Township Road 180 (Wapakoneta-Buckland Road), and the North line of Section 18, Duchouquet Township, a distance of 999.61 feet to a spike and the PLACE OF BEGINNING;

thence continuing N.90°00'E. along said centerline and the North line of Section 18, Duchouquet Township, a distance of 286.50 feet to a spike;

thence S.00°58'30"W. a distance of 694.37 feet to a point in the centerline of a creek, passing thru an iron pin for reference at 680.37 feet;

thence S.73°13'34"W. along the centerline of the creek a distance of 155.09 feet to a point, being referenced by an iron pin at N.13°20'30"W., 17.00 feet;

thence N.62°03'38"W. along the centerline of the creek a distance of 155.67 feet to a point, being referenced by an iron pin at N.00°58'30"E., 33.00 feet;

thence N.00°58'30"E. a distance of 666.19 feet to a spike in the centerline of Township Road 180 and the North line of Section 18, Duchouquet Township, said spike was the true PLACE OF BEGINNING.

Containing in all 4.67 acres of which 0.11 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements and restrictions, if any, of record or in use on said premises. Previous deed reference: Vol. 185, pg. 686. The above plat is recorded in survey book G, page 444, in the Auglaize County Engineers office. For further reference see Plat Cabinet "A", Slide 278, in the Auglaize County Records office.
