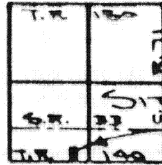

SECTION 36

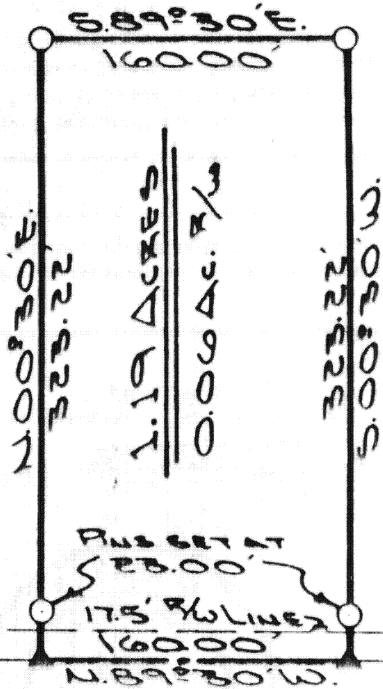


NOBLE TOWNSHIP

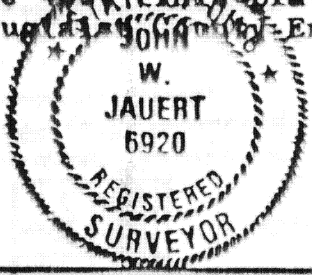

The following described tract of land is part of the Southeast Quarter of the Southwest Quarter of Section 36, Noble Township, T-5-S, R-4-E, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Southwest Quarter of Section 36, Noble Township and the centerline of Township Road 140 (Geiger Road);  
thence with an assumed bearing of N. 89° 30' W. along the South line of the Southwest Quarter of said Section and the centerline of T.R. 140 a distance of 594.73 feet to a R.R. Spike and the PLACE OF BEGINNING;  
thence continuing N. 89° 30' W. along the South line of the Southwest Quarter of said Section and the centerline of T.R. 140 a distance of 160.00 feet to a R.R. Spike;  
thence N. 00° 30' E. a distance of 323.22 feet to an iron pin;  
thence S. 89° 30' E. a distance of 160.00 feet to an iron pin;  
thence S. 00° 30' W. a distance of 323.22 feet to a R.R. Spike, which was the true PLACE OF BEGINNING.

Containing in all 1.19 acres of which 0.06 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements and restrictions, if any, of record or in use on said premises. Previous deed references: Vol. 154, page 406. This plat is recorded in Survey book G, page 471, in the Auglaize County Engineer's office.
