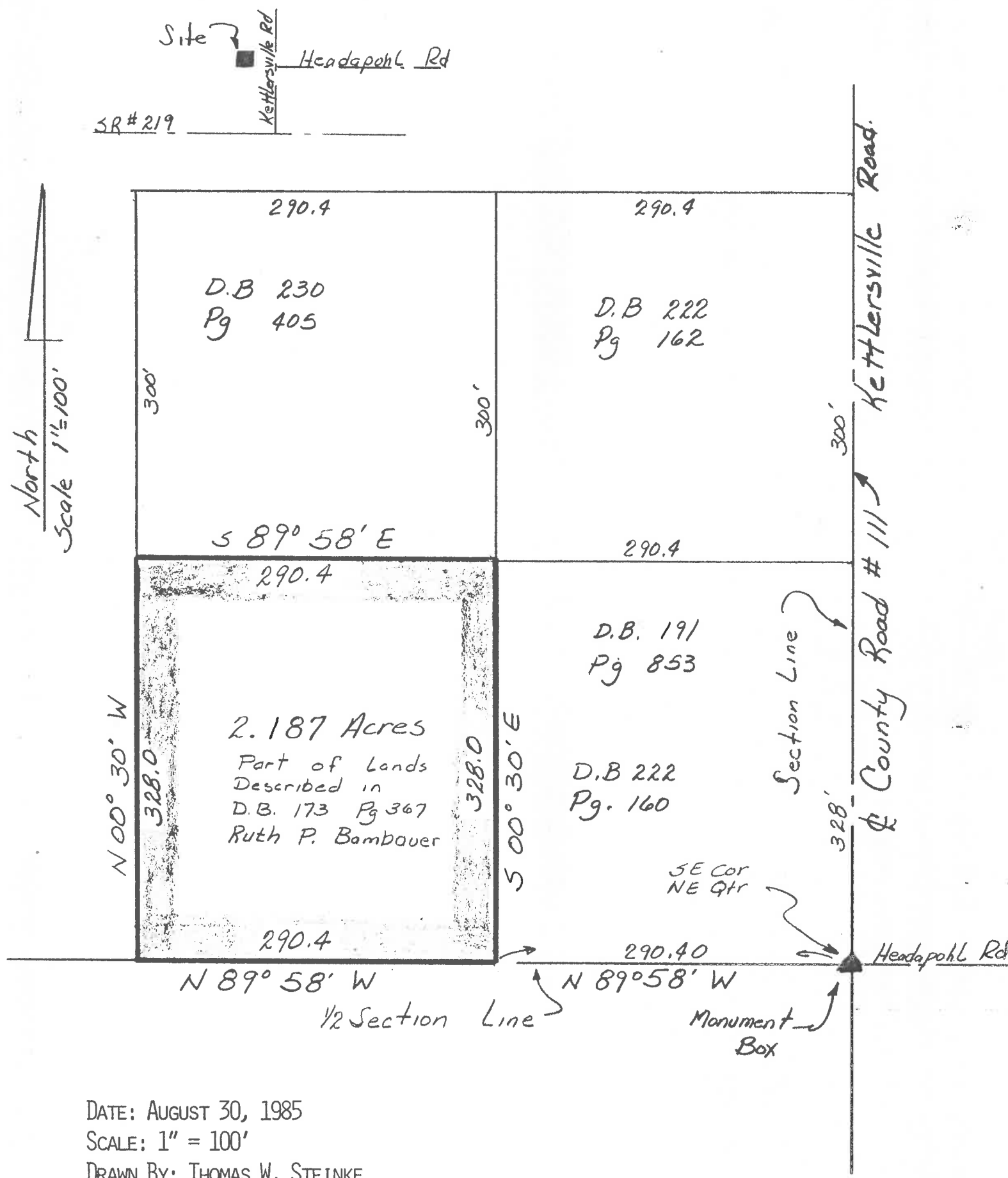


SURVEY FOR BAMBAUER FERTILIZER AND SEED INC

BEING 2.187 ACRES LOCATED IN THE NORTHEAST QUARTER OF SECTION 22, TOWN 6 SOUTH, RANGE 5 EAST, WASHINGTON TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS;

COMMENCING AT A MONUMENT BOX LOCATED AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 22, ALSO BEING THE CENTERLINE OF KETTLERSVILLE ROAD C.R.# 111 AND HEADAPOHL ROAD;

THENCE NORTH $89^{\circ} 58'$ WEST ALONG THE HALF SECTION LINE, A DISTANCE OF 290.40 FEET TO THE PLACE OF BEGINNING FOR THE PARCEL HEREIN DESCRIBED;

THENCE CONTINUING NORTH $89^{\circ} 58'$ WEST ALONG SAID SECTION LINE, A DISTANCE OF 290.40 FEET TO A POINT;

THENCE NORTH $00^{\circ} 30'$ WEST, A DISTANCE OF 328.00 FEET TO A POINT AT THE SOUTHWEST CORNER OF LANDS DESCRIBED IN DEED VOL. 230 PAGE 405;

THENCE SOUTH $89^{\circ} 58'$ EAST ALONG THE SOUTH LINE OF SAID REFERENCE PROPERTY, A DISTANCE OF 290.40 FEET TO A POINT AT THE NORTHWEST CORNER OF LANDS DESCRIBED IN DEED VOL 222 PAGE 160;

THENCE SOUTH $00^{\circ} 30'$ EAST ALONG THE WEST LINE OF SAID REFERENCE PROPERTY, A DISTANCE OF 328.00 FEET TO THE SOUTH LINE OF THE NORTHEAST QUARTER OF SECTION 22 AND THE PLACE OF BEGINNING.

CONTAINING IN ALL 2.187 ACRES AND BEING SUBJECT TO ALL LEGAL EASEMENTS AND RIGHTS-OF-WAY OF RECORD.
