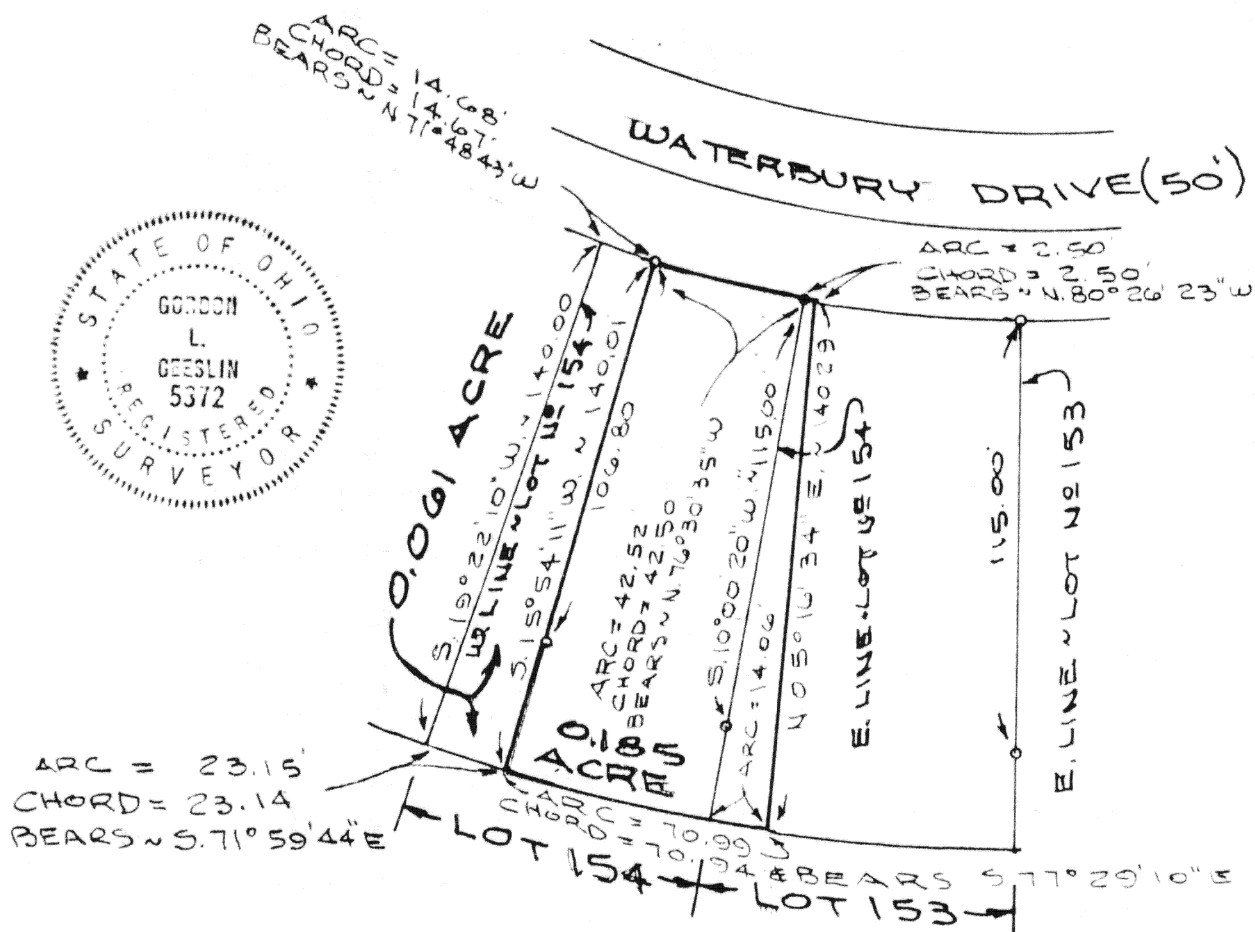

FRAZE SURVEY DESCRIPTION

(Westerly portion of Lot 154)

Being the westerly portion of Lot number 154 in Section "E" of Southmoor Shores Subdivision in Section 17, St. Marys Township, Auglaize County, Ohio. Being more particularly described as follows:

Commencing for reference at a 5/8 inch iron bar at the northeast corner of said Lot number 154-

Thence, westerly, along the curved north line of said Lot number 154, an arc distance of forty-two and 52/100 (42.52) feet to a 5/8 inch iron bar. The chord to the last described call bears north 76°30'35" west, 42.50 feet. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing westerly along the curved north line of said Lot number 154, an arc distance of fourteen and 68/100 (14.68) feet to the northwest corner thereof, The chord to the last described call bears north 71°48'43" west, 14.67 feet-

Thence, south 19°22'10" west, along the west line of said Lot number 154, a distance of one hundred forty (140.00) feet to the southwest corner thereof-

Thence, easterly, along the curved south line of said Lot number 154, an arc distance of twenty-three and 15/100 (23.15) feet to a point. The chord to the last described call bears south 71°59'44" east, 23.14 feet-

Thence, north 15°54'11" east, a distance of one hundred forty and 01/100 (140.01) feet to the place of beginning.

Containing 0.061 acre of land more or less.

Subject to all easements and right-of-way or record.

Beginning at a 5/8 inch iron bar at the northeast corner of said Lot number 154-

Thence, westerly, along the curved north line of said Lot number 154, an arc distance of forty-two and 52/100 (42.52) feet to a 5/8 inch iron bar. The chord to the last described call bears north 76°30'35" west, 42.50 feet-

Thence, south 15°54'11" west, a distance of one hundred forty and 01/100 (140.01) feet to a point in the south line of said Lot 154-

Thence, easterly, along the curved south line of Lot 154 and 153, an arc distance of seventy and 99/100 (70.99) feet to a point. The chord to the last described call bears south 77°29'10" east, 70.94 feet-

Thence, north 05°16'34" east, a distance of one hundred forty and 29/100 (140.29) feet to a point in the north line of said Lot 153-

Thence, westerly, along the curved north line of Lot 153, an arc distance of two and 50/100 (2.50) feet to the place of beginning. The chord to the last described call bears north 80°26'23" west, 2.50 feet-

Containing 0.185 acre of land more or less.
