DESCRIPTION - Lot SEPTEMBER 25, 1985 1.77 acres H-166

BEING A PARCEL OF LAND SITUATED IN GOSHEN TOWNSHIP, AUGLAIZE COUNTY, OHIO IN THE SOUTHEAST QUARTER OF SECTION 25, TOWNSHIP 5 SOUTH- RANGE 8 EAST, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING FOR REFERENCE AT A P. K. NAIL FOUND FOR THE INTERSECTION OF THE COUNTY LINE BETWEEN AUGLAIZE COUNTY AND HARDIN COUNTY WITH THE CENTERLINE OF TOWNSHIP ROAD 180 (HARDIN COUNTY) -

THENCE NORTH ALONG SAID COUNTY LINE AND EAST LINE OF BECTION 25 (GOSHEN TWP.) FOR A DISTANCE OF 1311.08 FEET TO AN IRON PIN FOUND-

THENCE SOUTH 88 DEGREES-37 MINUTES-44 SECONDS WEST A DISTANCE OF 332.56 FEET TO AN IRON PIN FOUND MARKING THE POINT OF BEGINNING FOR THE PARCEL TO BE DESCRIBED-

- (1) THENCE NORTH 88 DEG.-41 MIN.-05 SEC, WEST FOR A DISTANCE OF 290.60 FEET TO AN IRON PIN SET-
- (2) THENCE NORTH O DEG.-13 MIN.-25 SEC. WEST FOR A DISTANCE OF 265.00 FEET TO AN IRON PIN SET-
- (3) THENCE SOUTH 88 DEG.-41 MIN.-05 SEC. EAST FOR A DISTANCE OF 290.60 FEET TO AN IRON PIN FOUND-
- (4) THENCE SOUTH O DEG.-13 MIN.-25 SEC. WEST FOR A DISTANCE OF 265.00 FEET TO THE POINT OF BEGINNING.
