Commencing at a iron pin found at the Southeast corner of said Northeast quarter of said St. Marys Township; thence N 00°00°00" E with the east line of said Northeast quarter (also the centerline of State Route 364), 806.12 feet to a PK nail set and the PLACE OF BEGINNING thence continuing N 00°00°00" E with said east line and centerline, 50.00 feet to a PK nail set; thence S 89°52'00" W (passing through a 5/8 inch rebar set; thence S 89°52'00" E, 529.20 feet to a 5/8 inch rebar set; thence S 00°08'00" E, 823.91 feet to a 5/8 inch rebar set; thence N 89°52'00" E, 823.91 feet to a 5/8 inch rebar set; thence N 00°08'00" W, 479.20 feet to a 5/8 inch rebar set; thence N 89°52'00" E (passing through a 5/8 inch rebar set; thence N 89°52'00" E (passing through a 5/8 inch rebar set at 458.75 feet), 483.75 feet to the PLACE OF BEGINNING containing 10.686 acres more or less and subject to all highway and other legal easements of record.

Commencing at a iron pin found at the Southeast corner of said Northeast quarter of said St. Marys Township; thence N $00^{\circ}00^{\circ}00^{\circ}$ E with the east line of said Northeast quarter (also the centerline of State Route 364), 326.92 feet to a PK nail set and the PLACE OF BEGINNING thence S $89^{\circ}52^{\circ}00^{\circ}$ W (passing through a 5/8 inch rebar set at 25.00 feet), 482.65 feet to a 5/8 inch rebar set; thence N $00^{\circ}08^{\circ}00^{\circ}$ W, 479.20 feet to a 5/8 inch rebar set; thence N $89^{\circ}52^{\circ}00^{\circ}$ E (passing through a 5/8 inch rebar set at 458.75 feet), 483.75 feet to a PK nail on the east line of said Northeast quarter and the centerline of State Route 364; thence S $00^{\circ}00^{\circ}00^{\circ}$ W with said east line and centerline, 479.20 feet to the PLACE OF BEGINNING containing 5.316 acres more or less and subject to all highway and other legal easements of record.
