




LOCATION PLAN

The following described tract of land is part of the Southeast Quarter of the Northeast Quarter of Section 9, Twn 5 South, Range 4 East, Noble Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Northeast Quarter of Section 9, Noble Township;

thence with an assumed bearing of N.00°30'E, along the center line of County Road 41-A (St. Marys River Road) and the East line of Section 9, Noble Township, a distance of 900.26 feet to a R.R. spike and the PLACE OF BEGINNING;

thence N.89°52'50"W, a distance of 235.00 feet to an iron pin, passing thru an iron pin at 25.00 feet in the West right-of-way line of County Road 41-A;

thence N.00°30'E, on a line parallel to the East line of Section 9 and the centerline of County Road 41-A, a distance of 355.00 feet to an iron pin;

thence S.89°52'50"E, a distance of 235.00 feet to a R.R. spike, passing thru an iron pin at 210.00 feet in the West right-of-way line of County Road 41-A;

thence S.00°30'W, along the East line of Section 9 and the centerline of County Road 41-A, a distance of 355.00 feet to a R.R. spike which was the true PLACE OF BEGINNING;

Containing in all 1.91 acres of which 0.20 acre has been dedicated for highway purposes. The above tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume O.R. 29, page 461. This plat is recorded in Survey Book 6, page 685, in the Auglaize County Engineer's Office.
