



SURVEYORS' DESCRIPTION

The following described tract of land is part of the Southeast Quarter of the Southeast Quarter of Section 31, Union Township, Town Five (5) South, Range Seven (7) East, Auglaize County, Ohio, and is more particularly described as follows;

Commencing at a point being located at the intersection of the East Section line of Section 31, Union Township, and the Centerline of Federal Route 33, Tangent Station 1098 + 29.21 of the 1966 centerline survey, as found on sheet 6 of 18, Ohio Department of Transportation, Division Seven (7) Plans;

thence with a bearing of N. 89°-05' W., and along the Tangent centerline of Route 33, a distance of 283.68 feet to a P.K. nail and the PLACE OF BEGINNING;


thence continuing with a bearing of N. 89°-05' W., and along the centerline of Route 33, a distance of 199.24 feet to a P.K. nail;

thence with a bearing of N. 01°-52'-07" E. a distance of 420.64 feet to an iron pin, and passing thru an iron pin set on the north right-of-way line of Route 33 at a distance of 55.01 feet;

thence with a bearing of S. 89°-05' E., and parallel with the centerline of Route 33, a distance of 199.24 feet to an iron pin;

thence with a bearing of S. 01°-52'-07" W. a distance of 420.64 to a P.K. nail and the PLACE OF BEGINNING, and passing thru an iron pin set on the north right-of-way line of Route 33 at a distance of 380.36 feet.

Containing in all 1.923 acres of land, of which 0.229 acre being designated as right-of-way for Federal Route 33. The above described tract of land is subject to all restrictions, easements, assessments, or reservations, if any, on said premises.
