


LEGEND

- ▲ R.R. SPIKE FOUND


LOCATION PLAN

The following described tract of land is part of the Northwest Quarter of the Southwest Quarter of Section 9, Wayne Township, Town 5 South, Range 8 East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a monument box at the Northwest corner of the Southwest Quarter of Section 9, Wayne Township, said monument box also being in the centerline of Township Road 271 (Moyer Road);

thence with an assumed bearing of S.00°00'W. along the West line of the Southwest Quarter of Section 9, Wayne Township and the centerline of Township Road 271, a distance of 165.00 feet to a R.R. spike which is the PLACE OF BEGINNING;

thence N.89°22'E. a distance of 593.04 feet to an iron pin;

thence S.00°00'W., parallel to the West line of the Southwest Quarter of Section 9, Wayne Township and the centerline of Township Road 271, a distance of 116.00 feet to an iron pin;

thence S.89°22'W. a distance of 436.04 feet to an iron pin;

thence S.00°00'W., parallel to the West line of the Southwest Quarter of Section 9, Wayne Township and the centerline of Township Road 271, a distance of 26.00 feet to an iron pin;

thence S.89°22'W. a distance of 157.00 feet to a R.R. spike in the centerline of Township Road 271, passing thru an iron pin in the East right-of-way line of Township Road 271 at 137.00 feet;

thence N.00°00'E. along the West line of the Southwest Quarter of Section 9, Wayne Township and the centerline of Township Road 271, a distance of 142.00 feet to a R.R. spike which was the true PLACE OF BEGINNING.

Containing 1.67 acres of which 0.06 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 181, page 544. This plat is recorded in Survey Book G, page 735 in the Auglaize County Engineer's Office.
