DAVIS TO BOARD OF EDUCATION

Being a parcel of land located in Outlot 16 in the City of St. Marys, Auglaize County, Ohio, and being more particularly described as follows:

Commencing for reference at a P.K. nail at the intersection of the centerlines of N. Spruce St. and Armstrong Street, thence S 89°36'35" E, along the centerline of Armstrong St., a distance of four hundred forty-six and 01/100 (446.01) feet to a P.K. nail;

Thence, N 21°18'35" E, parallel with the centerline of N. Spruce St., a distance of thirty-five and 33/100 (35.33) feet, to a railroad spike, said point being the place of beginning for the following described parcel:

Thence, continuing, N 21°18'35" E, along the west line of a parcel of land as conveyed to the St. Marys Board of Education by deed Vol. 166, Pg. 38 and Vol. 166, Pg. 173 of the Auglaize County Recorder's Records, a distance of two hundred seven and 86/100 (207.86) feet to a point, said point being zero and 05/100 (0.05) feet west of a 5/8" iron bar at the southeast corner of the Meadowview Two - Section Two Subdivision;

Commencing for reference at a K.R. spike at the southwest corner of a parcel of land as conveyed to the Board of Education, St. Marys School District in Volume 166, Page 38, and Volume 166, Page 173, of the Auglaize County Recorder's Records, said point being on the north right-of-way line of Armstrong St., thence, N 89° 36' 35" W, along the said north right-of-way line of Armstrong St. a distance of twenty-one and 27/100 (21.27) feet to the place of beginning for the following described easement;

Thence, continuing, N 89° 36' 35" W, along the said north right-ofway line of Armstrong St., a distance of ten and 45/100 (10.45) feet to a point;

Thence, N 16° 56' 51" E, a distance of two hundred two and 54/100 (202.54) feet to a point on the south line of Meadowview Subdivision;

Thence, $5.89^{\circ}.38^{\circ}.03^{\circ}$ E, along the said south line of Meadowview Subdivision, a distance of ten and 45/100 (10.45) feet to a point;

This call should have read South 89° 36' 35" East to the place of beginning.
